# 3.1 Displacement Response Strategy - Acquisition/Preservation, Community Ownership Action Plan, and Other Efforts

By consensus, the Council indicated support for committing up to \$4 million in City housing funds to catalyze outside funding of at least \$16 million, for a total fund of \$20 million minimum with openness to making funding accessible with safeguards, available earlier than the June 2025 completion timeframe and/or available before the total fund reaches \$20 million.

By consensus, the Council indicated support for City staff's recommended community ownership action plan process and looking at the pros/cons of Opportunity to Purchase as part of community ownership action plan and making action plan criteria available for stakeholder review before finalizing.

By consensus, the Council indicated support for City staff's recommendations related to "alternatives to displacement," and evaluating Senate Bill 649.

Introduce an Ordinance of the City of Mountain View Amending Sections 8.174.2, 8.174.4, 8.174.5, and 8.174.8 of Chapter 8 (Buildings), Article VIII (Floodplain Management) of the City of Mountain View City Code to Bring the Design and Installation of Manufactured Homes into Compliance with the Federal Emergency Management Agency National Flood Insurance Program and Finding the Ordinance is Not a Project Under the California Environmental Quality Act, and set a second reading for March 26, 2024.
