A RESOLUTION AMENDING RESOLUTION NO. 18250, PROHIBITING AND RESTRICTING PARKING ON DESIGNATED STREETS, OR PORTIONS THEREOF, TO DESIGNATE ADDITIONAL LOCATIONS WHERE VEHICLE PARKING IN EXCESS OF TWO HOURS BETWEEN 9:00 A.M. AND 6:00 P.M. IS PROHIBITED PURSUANT TO MOUNTAIN VIEW CITY CODE SECTION 19.95(a)

WHEREAS, the Mountain View City Code prohibits and restricts parking under various circumstances pursuant to Chapter 19 of the Mountain View City Code; and

WHEREAS, Mountain View City Code Section 19.95(a) prohibits parking in excess of two hours between the hours of 9:00 a.m. and 6:00 p.m. upon streets, or parts thereof, or upon any of the public parking lots as designated by resolution of the City Council; and

WHEREAS, the City completed construction of Mora Park, located at Ortega Avenue and Mora Place, Mountain View; and

WHEREAS, in accordance with Mountain View City Code Section 19.95(a), the City of Mountain View desires to designate the portions of streets adjacent to Mora Park as a two-hour parking zone by adding them to Table 19.95A designating “Two-Hour Parking Zones, 9:00 a.m. to 6:00 p.m.,” as previously adopted by Resolution No. 18250; now, therefore, be it

RESOLVED: by the City Council of the City of Mountain View that pursuant to Mountain View City Code Section 19.95(a), the parking of vehicles in excess of two hours between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and public holidays is prohibited at the additional locations designated below to be added to Table 19.95A:

Table 19.95A
Two-Hour Parking Zones, 9:00 a.m. to 6:00 p.m.

STREET	SIDES OF STREET	PORTION
Mora Place	North	Easterly line of Ortega Avenue to a point 127 feet easterly therefrom.
Ortega Avenue	East	Northerly line of Mora Place to a point 185 feet northerly therefrom.


