- 1. Acknowledge and file the Fiscal Year 2020-21 Third Quarter Budget Status Report and the Fiscal Year 2021-22 Preliminary General Operating Fund Forecast Update.
- 2. Direct staff to bring back staff's recommendations on the use of American Rescue Plan Act funding including the following changes: 1) allocate \$1,000,000 for a universal basic income program; 2) allocate \$1,000,000 for Mountain View Solidarity Fund; 3) shift \$1,000,000 from the rent relief program to the Community Services Agency (\$750,000 to be used for direct financial assistance and \$250,000 to be used at the discretion of

Community Services Agency) and authorize staff to negotiate an administrative fee consistent with prior direction from the Council; 4) shift \$100,000 from Transit Center Master Plan to small business grant program/relief; and 5) subtract \$50,000 from technology equipment, hardware, and IT contracts and reallocate to eviction prevention and defense program.
