*Mayor Abe-Koga provided an overview on the City of Mountain View's COVID-19 response and the development of a COVID-19 Resiliency Recovery Plan.*

*The Mayor asked the Commission to provide feedback on the following two questions: 1)*

*What challenges and opportunities do you see for our community and 2) Where could our collective efforts be focused in the months and years ahead?*

*Commissioners provided the following feedback:*

*Challenges:*

*Availability of mental health services for low income groups and recent immigrants  
Concern about vehicle dwellers who can't participate in programs because of undocumented status and the public charge rule  
Concern about lack of availability of mental health beds in Santa Clara County hospitals  
Concern that low to middle income families can't qualify for support programs. What are the available programs for that group?  
Look at other sources of help for low-income renters, families, and landlords. Limited resources with unlimited needs.  
Food insecurity, education gap and digital divide, financial impacts on working/middle class women, immigrants, small businesses, seniors, and people with disabilities.  
Racism in the community.  
The effects of isolation on people's mental health  
Lack of civil conversations  
Concern with City stepping away from sustainability commitments*

*Opportunities:*

*Increased philanthropy, volunteerism, increased teleworking/telecommuting, opportunity to envision a new community, ending the digital divide, redeploy workers to serve as contact tracers.*
