Discuss one City Council goal and what it means to you.

The topic that I find most impactful for our current state of affairs is the "Intentional Development & Housing Options" list of goals, but that is addressed in the following question. One of the next most important goals to me is the updating and maintaining of the "Livability and Quality of Life" goal list. I believe that this section is where our city will acquire the most growth in community and culture. We must maintain a space that families young and old can enjoy and be proud of while helping the local economy. When citizens feel safe and have the appropriate outlets they put money back into that community in the form of patronizing local businesses, restaurants, entertainment, and services. By specifically focusing on a few items from this section of the action plan such as, continuing to work with the Visual Arts Committee to encourage public art and working to prioritize preserving the character of the downtown core, we can create a city that citizens not only enjoy, but are proud to be a part of.

What are your thoughts/ideas for improving the housing supply to meet today's requirements (including R3) as well as planning for the future?

I believe that this issue is at the forefront of evolution for Mountain View and as a young professional I believe that I have an interesting insight into the issue of affordable housing and community expansion. With planning for future housing it is all about the balance of maintaining the high quality of life that we have created over the years in Mountain View while creating affordable options for those who have not yet bought into the housing market in our city. In terms of R3 districts I believe the city is already well on its way to solving the problem. Creating high quality options such as stacked flats and apartment complexes that are in specific districts not intermingling with single family homes creates an environment that benefits all citizens of Mountain View. Maintaining the integrity of these separate housing ideals maintains that all citizen needs are met, whether it is a four bedroom home for your family or a small affordable apartment for a young professional just starting out their life. If we slightly loosen construction restrictions in specific areas that allow for larger more affordable apartment buildings and not just high cost row houses we can create a large stock of new housing options for all the diverse communities that exist here. However, with this comes the issue again of balance. We must integrate them accordingly in specific zones as to not overrun the smaller neighborhood single family homes and ruin the family style community that already exists here in Mountain View. I believe that through R3 district changes we can truly acheive " Community for All"
