I love the wide spectrum of PRC workplan and focus areas, and believe that my experiences enable me to contribute both well-rounded and unique (Youth Sports, City/Schools issues, County Programs) perspectives. I appreciate listening to input from City residents and enjoy working with residents and City staff on thoughtful solutions to both longstanding and newly emerging issues.

I'm fortunate to live in a city that shares the value of increasing open space and access to parks and programs throughout ALL of our neighborhoods, and searches for solutions through an equity lens, with a particular focus on underserved groups and city planning areas. As our city grows, parks and open space remain critical to a vibrant and healthy community. I would love to contribute as we work towards that vision.

One of our City's current challenges is managing urban and housing growth, while simultaneously enhancing and increasing City parks and open space. A further challenge is to have open space and open space policies which are good for the active/passive recreational needs of our residents, and also positively impact the biodiversity of our local environment. I would be extremely excited to continue working on the City's two major initiatives in the above areas: The PRC Strategic Plan and the Biodiversity Strategy.

The Strategic Plan process will drive a comprehensive and critical look at current data, stakeholder input, and best practices from other jurisdictions. It will provide a fresh look at how the city manages all aspects of Parks and Recreation, and will enable Mountain View to be more knowledgeable, cohesive, and nimble in planning for the next 10+ years. I'm sensitive to ensuring ALL voices are heard in the feedback iterations and will make suggestions for improving outreach if needed.

The Biodiversity Strategy will look at the interrelationships between our plants, wildlife, and environment. It will provide recommendations for preserving and growing habitats and urban spaces that are supportive to each of those interconnected areas. The Biodiversity Strategy will also present an opportunity to study our citywide tree policies, including a possible refresh of the Heritage Tree Ordinance. I've been anxiously anticipating approaches for expanding the city's canopy and green spaces, and would be excited to be at the forefront of this planning.
