### General Permit Guidelines:

1. All permits are valid for one year from \_\_\_\_\_ to \_\_\_\_\_.
2. These permits are for the sole use of the residents and their guests located within (insert name of the Residential Parking Permit (RPP) Zone).
3. Vehicles displaying the permits properly will be exempt from the on-street, time-limited parking within the above RPP Zone.
4. These permits are valid for the zone for which the permits are issued for only and are not valid in any other part of the City.
5. Vehicles without the permits or vehicles not displaying permits properly exceeding the on-street, time-limited parking will be subject to citation.
6. Sticker-type residential permit must be pasted on the left side of the rear bumper.
7. Hanger-type of guest permit must be hung on the rearview mirror.
8. It is the responsibility of the resident to renew the permit(s) as well as to see that each guest displays the permit in the manner indicated.

10. Permit cost is not prorated.
11. There is no refund or free replacement of a lost or stolen guest permit.
12. Permits must not be sold, transferred, or allocated to another person.
13. Misuse or fraud may result in City cancelling all the permits issued to your household.
