4.1 AB 361 Resolution to Continue Remote Public Meetings During State of Emergency

Adopt Resolution No. 18751 of the City Council of the City of Mountain View Authorizing and Continuing Virtual Meetings of City Council, Committees, Boards and Commissions Pursuant to AB 361 and Making Required Findings.

4.2 Charleston Transit Boulevard-Extension of Temporary Bus Lanes

Adopt Resolution No. 18752 of the City Council of the City of Mountain View Amending Resolution No. 18575, Temporarily Designating for Exclusive Use Bus-Only Lanes Along Charleston Road, from Landings Drive to Shoreline Boulevard, Pursuant to California Vehicle Code Section 21655.5 and Finding the Resolution to be Exempt from the California Environmental Quality Act Under California Code of Regulations Title 14, Section 15301.

8. CLOSED SESSION REPORT

City Attorney Logue stated the Council took final action on Item 2.1 on the Closed Session agenda, which was a conference with legal counsel regarding a liability claim filed by Paul Mansourian against the City of Mountain View and Mountain View police Sergeant Scott Thomas. She stated Mr. Mansourian's claim sought \$450,000 in damages based on the alleged violation of his Fourth Amendment right to be free from unlawful seizure when Sgt. Thomas took him into custody for driving under the influence of alcohol. She stated the Council voted with 6 ayes, 0 noes, 0 abstentions and 0 absences to deny the claim.

City Attorney Logue stated the Council took final action on Item 2.2 on the Closed Session agenda, which was a conference with legal counsel regarding a liability claim filed by Vijay Kumar against the City of Mountain View. She stated Mr. Kumar submitted a claim to the City of Mountain View seeking millions of dollars in damages because the United States Post Office incorrectly forwarded his mail to an individual named Vijay Kumar at an address in Florida. She stated the Council voted with 6 ayes, 0 noes, 0 abstentions and 0 absences to deny the claim.
