No formal motion was required. Committee members had positive feedback and provided the following comments: inform the public of the pilot project's design, purpose, and status; expand community outreach; ensure visibility at driveways and cross streets; look at adding planters at Escuela; and link evaluation metrics with Safe Routes to School and Vision Zero goals. The Committee would like future maps to show VTA bus stops and Mountain View Community Shuttle stops, and for the pilot project to incorporate improvements for all modes of transportation. Committee members expressed support for the idea of "Adopt a Planter Box" in which members of the public can fund the ongoing maintenance of planter boxes.
