Mayor Abe-Koga reported her attendance at a weekly meeting with County Mayors and County Supervisors Simitian and Chavez, a meeting with the Commute Free Work Task Force, and a meeting of the Bay Area Air Quality Management District Board.

## **10. CLOSED SESSION REPORT**

City Attorney Krishan Chopra stated Council met in Closed Session earlier this evening regarding Item 2.1 and authorized the City Manager to participate in the Employee Homebuyer and Relocation Assistance Program in accordance with Council Policy D-13, including a reduction in the property equity requirement from 10 percent to 5 percent and an extension of the relocation assistance reimbursement period beyond one year from the date of appointment.
