A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
LEVYING THE ANNUAL BENEFIT ASSESSMENTS FOR
CALENDAR YEAR 2023 FOR DOWNTOWN MOUNTAIN VIEW
BUSINESS IMPROVEMENT AREA NO. 2 AND AUTHORIZING THE CITY MANAGER OR DESIGNEE
TO ALLOCATE THE ASSESSMENTS TO FUND A CONTRACT FOR SERVICES
WITH THE MOUNTAIN VIEW CHAMBER OF COMMERCE

WHEREAS, on November 26, 1991, the City Council held a duly noticed public hearing in the City Council Chambers, 500 Castro Street, Mountain View, California, and formed the Downtown Mountain View Business Improvement Area (BIA) No. 2, pursuant to Ordinance No. 22.91 and in accordance with Sections 36500, *et seq.*, of the California Streets and Highways Code; and

WHEREAS, the City Council has reviewed and considered the Council report on BIA No. 2 and the proposed assessments and uses of revenues for calendar year 2023; and

WHEREAS, the Mountain View Chamber of Commerce, acting as the Advisory Board to the City Council on BIA No. 2, has filed the required annual report on the use of funds generated by the assessments in 2022 and the proposed uses for 2023, and the City Council has reviewed and considered said report; and

WHEREAS, on October 11, 2022, the City Council held a duly noticed public meeting at which it declared its intent to levy and collect assessments within BIA No. 2 as authorized by the California Streets and Highways Code, Section 36530, *et seq.*, and approved the report from the Mountain View Chamber of Commerce; and

WHEREAS, a notice of the proposed assessment has been published once in a newspaper of general circulation as required; and

WHEREAS, on November 15, 2022, the City Council held a duly noticed public hearing regarding the 2023 assessments and charges, and the uses to which revenues shall be put, which, as recommended by the Advisory Board, are consistent with the improvements and activities from 2022 and unchanged from Ordinance No. 22.91; now, therefore, be it

RESOLVED: that the City Council of the City of Mountain View has considered all public comments, oral and written, and hereby finds and determines that the protests, if any, received at the public hearing on calendar year 2023 assessments for BIA No. 2 do not constitute a majority

protest to the assessments, or to the types of improvements and/or activities to be funded with the revenues from the assessments; and be it

FURTHER RESOLVED: that the boundaries of BIA No. 2 are generally described as all businesses located on Castro Street between Evelyn Avenue to the north and California Street to the south, including all businesses with street addresses numbered 100 through 399 inclusive, as more particularly described in Exhibit A, attached hereto. All businesses within this area with a Castro Street address number 100 through 399 inclusive, excluding nonprofit organizations, are to be assessed as authorized in the Streets and Highways Code, Section 36500, *et seq.*, and as set forth herein. Said boundaries are unchanged from the boundaries established by Ordinance No. 22.91 on December 10, 1991; and be it

FURTHER RESOLVED: that the uses to which the revenue from BIA No. 2 are as follows:

- a. Promotion of public events which are to take place on or in public places in the area;
- b. Decoration of any public place in the area;
- c. Furnishing of music in any public place in the area;
- d. The general promotion of businesses within the area; and
- e. Other activities or improvements which benefit businesses located and operating in the Business Improvement Area; and be it

FURTHER RESOLVED: that the City Council hereby confirms the annual report as filed by the Mountain View Chamber of Commerce and shall levy an annual benefit assessment for the 2023 calendar year on all businesses, trades, and professions, excluding nonprofit organizations located within BIA No. 2, and collected with the annual City business license fee, and are hereby established as the following amounts:

Restaurants	\$125	\$150	\$175
Retail	\$75	\$100	\$125
Professional	\$25	\$50	\$75

; and be it

FURTHER RESOLVED: that the City Council hereby finds and determines that the businesses located within the aforesaid BIA No. 2 shall be benefited by the improvements and activities funded by the assessments to be levied pursuant to the Ordinance; and be it

FURTHER RESOLVED: that the improvements and activities provided in BIA No. 2 will be funded by the levy of the assessments. Revenues from the levy of the assessments within this area shall not be used to provide improvements or activities outside this area; and be it

FURTHER RESOLVED: that the City Council does hereby authorize the City Manager or designee to allocate all of the 2023 revenues from BIA No. 2 to fund a contract for services with the Mountain View Chamber of Commerce to accomplish the purposes of the area as set forth herein and in the referenced annual report and to accomplish the purposes of BIA No. 2.
