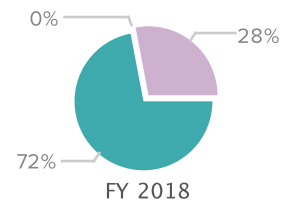

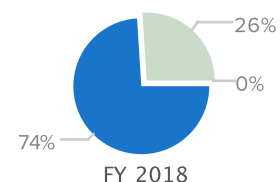
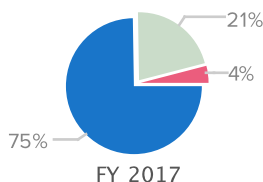
Revenue by Source
