A RESOLUTION AMENDING THE CITY OF MOUNTAIN VIEW  
MASTER FEE SCHEDULE TO INCLUDE A PAID PARKING FEE DURING EVENTS  
AT LEVI'S STADIUM IN SANTA CLARA FOR FISCAL YEAR 2014-15

WHEREAS, the City seeks to achieve and maintain financial stability through reasonable cost recovery where appropriate to allow the City to continue to provide cost-effective services; and

WHEREAS, Levi's Stadium in Santa Clara is set to open in August 2014. It is anticipated the attendees of events held at the stadium will rely on regional transit facilities to travel to and from Levi's Stadium, which may impact traffic and parking in the Mountain View downtown area and the Mountain View Transit Center; and

WHEREAS, the City of Mountain View seeks to initiate a pilot program to establish parking restrictions in the downtown, including Castro Street and City-owned parking lots, to ensure Mountain View residents and visitors who come to Mountain View on event days to eat, shop, and visit are able to park in City-owned parking lots; and

WHEREAS, the City of Mountain View seeks to initiate a pilot program for the attendees of events held at the stadium to establish a parking permit fee for event days at Levi's Stadium at a minimum amount of Ten Dollars (\$10.00) if the parking fee at the Caltrain Parking Lot remains at the daily rate of Five Dollars (\$5.00) or less than Ten Dollars (\$10.00), or an amount equal to the parking fee at the Caltrain Parking Lot in the event this fee exceeds Ten Dollars (\$10.00);

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View that the following fee is hereby adopted as set forth in the schedule attached hereto and incorporated herein as:
