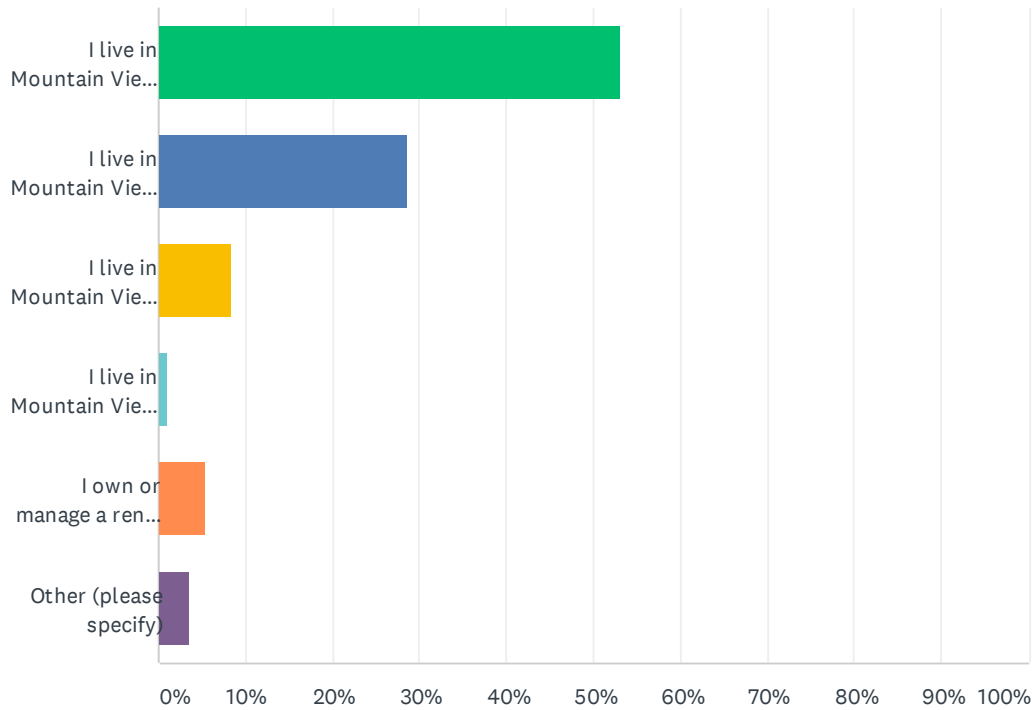

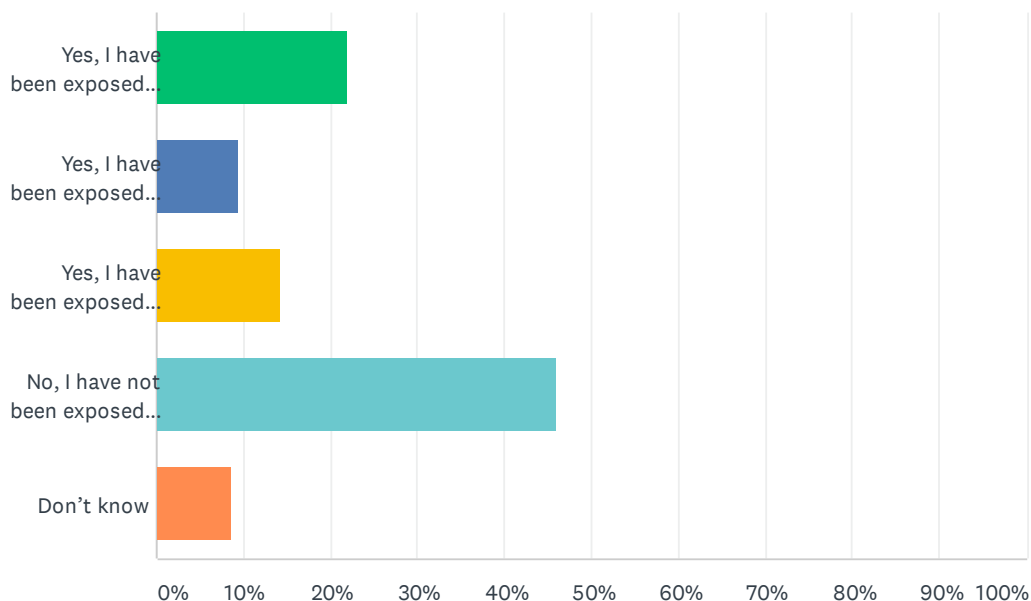

Q2 In the past 30 days, have you been exposed to secondhand smoke/vapor at your home?

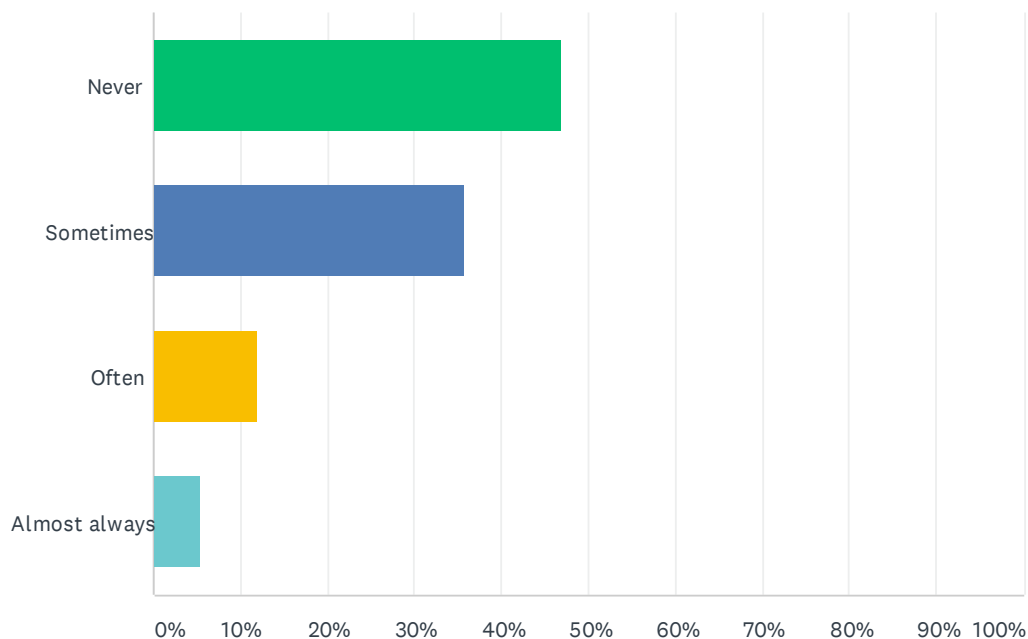

Q3 In the past 30 days, how often have you noticed secondhand smoke/vapor (tobacco and/or marijuana smoke/vapor) drifting into your home?

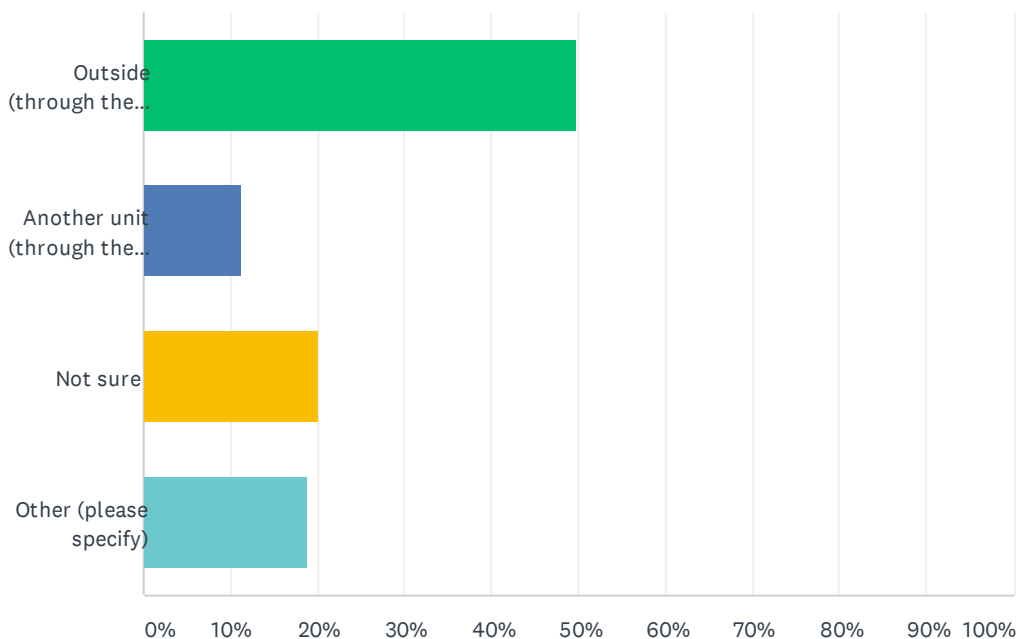

Q4 Where do you think that secondhand smoke/vapor drifted into your home from (Check all that apply)?

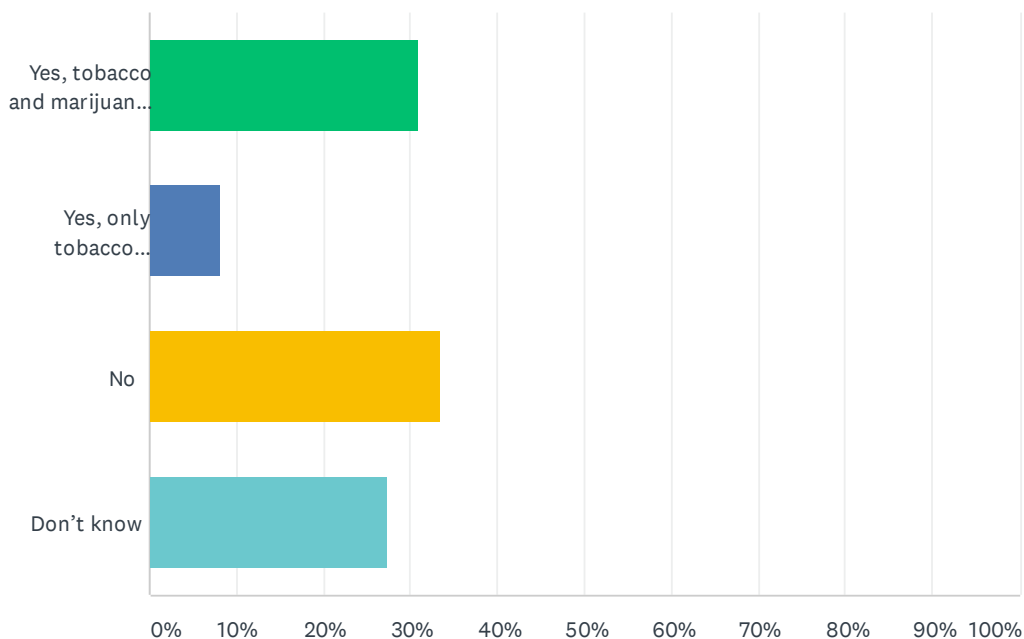

Q5 Does your housing complex have a policy to prohibit smoking/vaping inside your apartment?

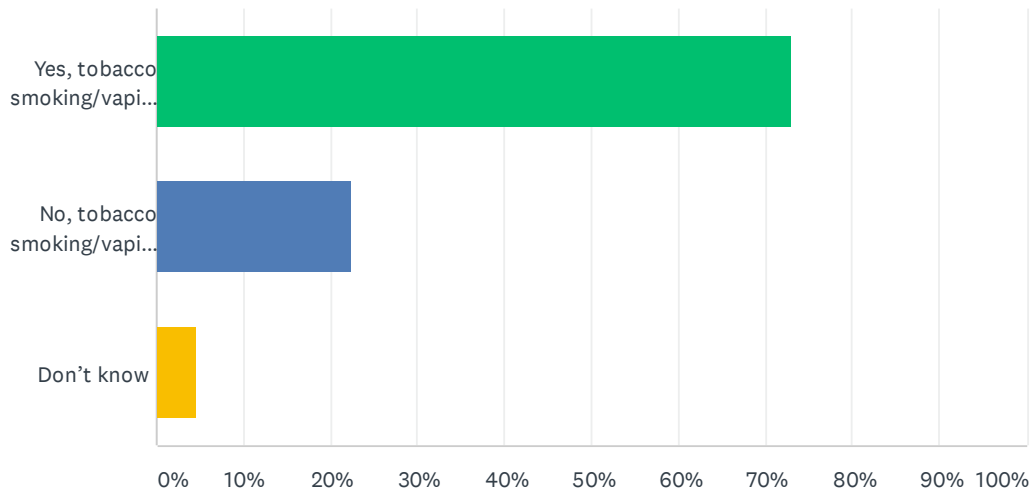

Q6 Do you think smoking/vaping tobacco should be prohibited inside apartments, triplexes, condominiums and townhomes?

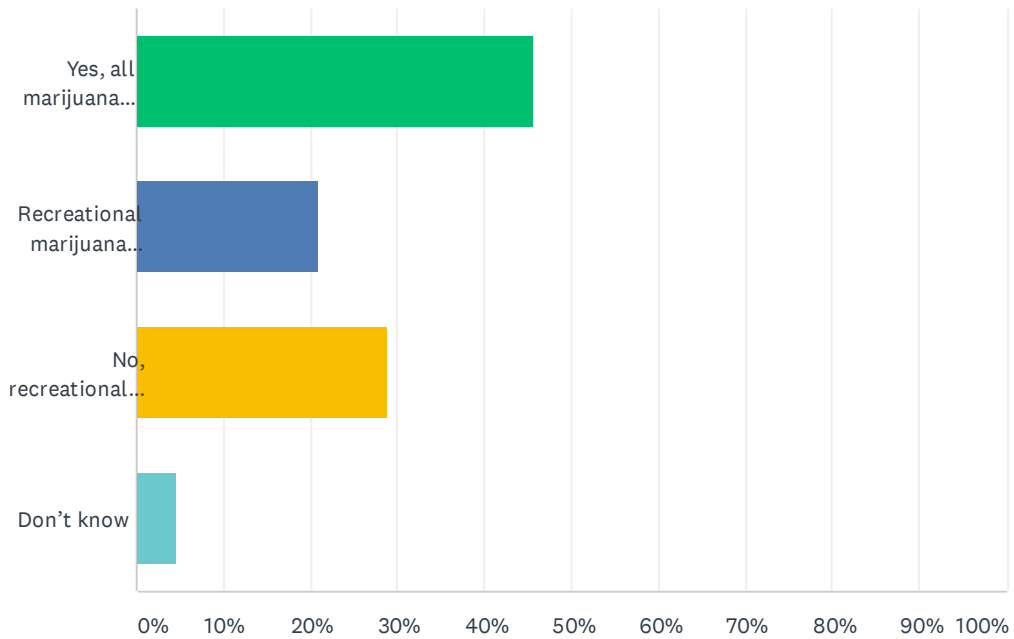

Q7 Do you think smoking/vaping marijuana should be prohibited inside apartments, triplexes, condominiums and townhomes?

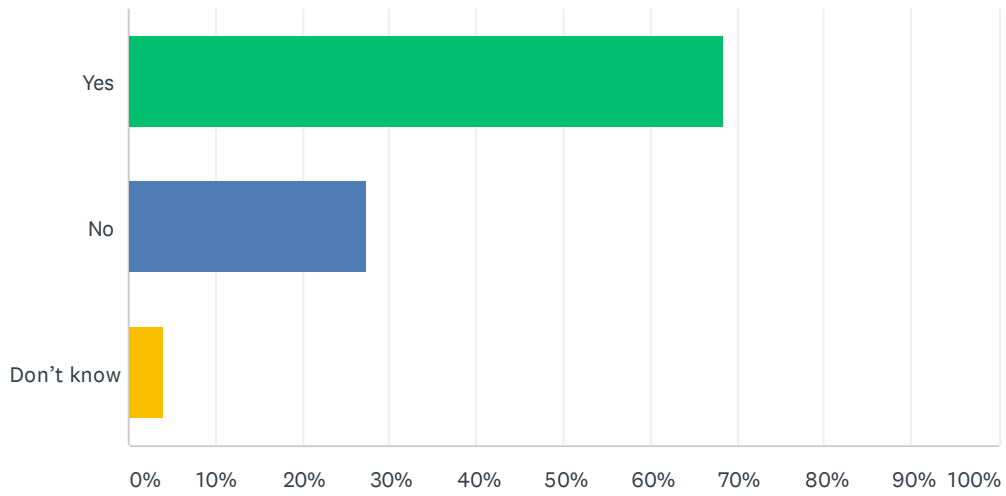

Q8 Do you think smoking/vaping should be prohibited in outdoor spaces such as private balconies and patios?

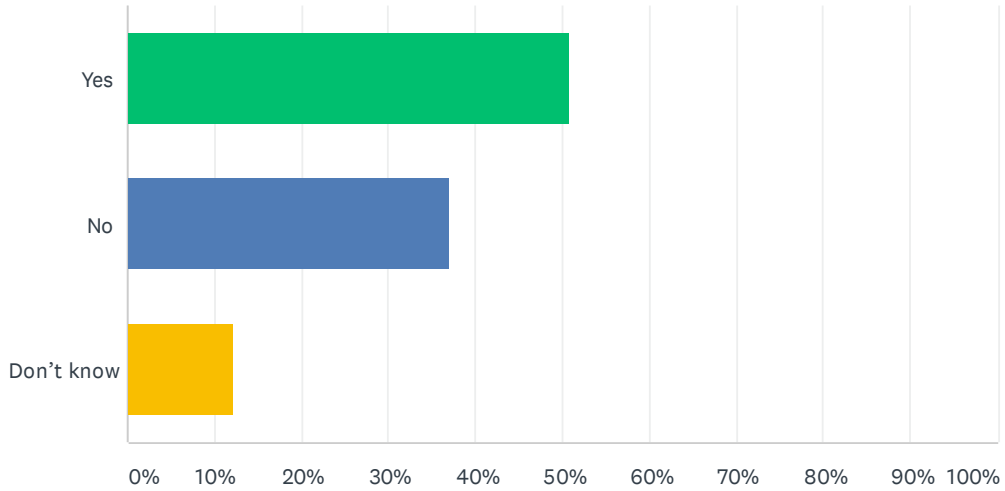

(Outdoor common areas currently required to be smoke free)**

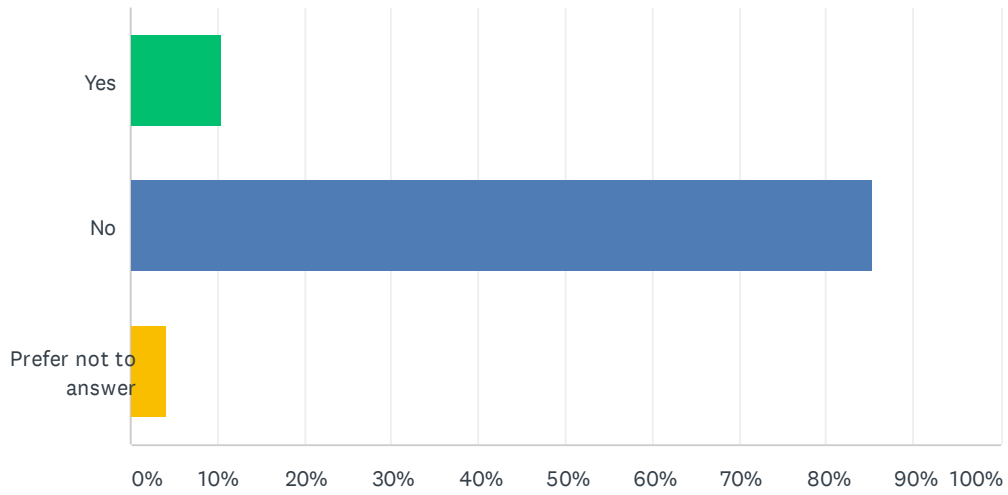

Q10 Do you smoke/vape tobacco or marijuana products?

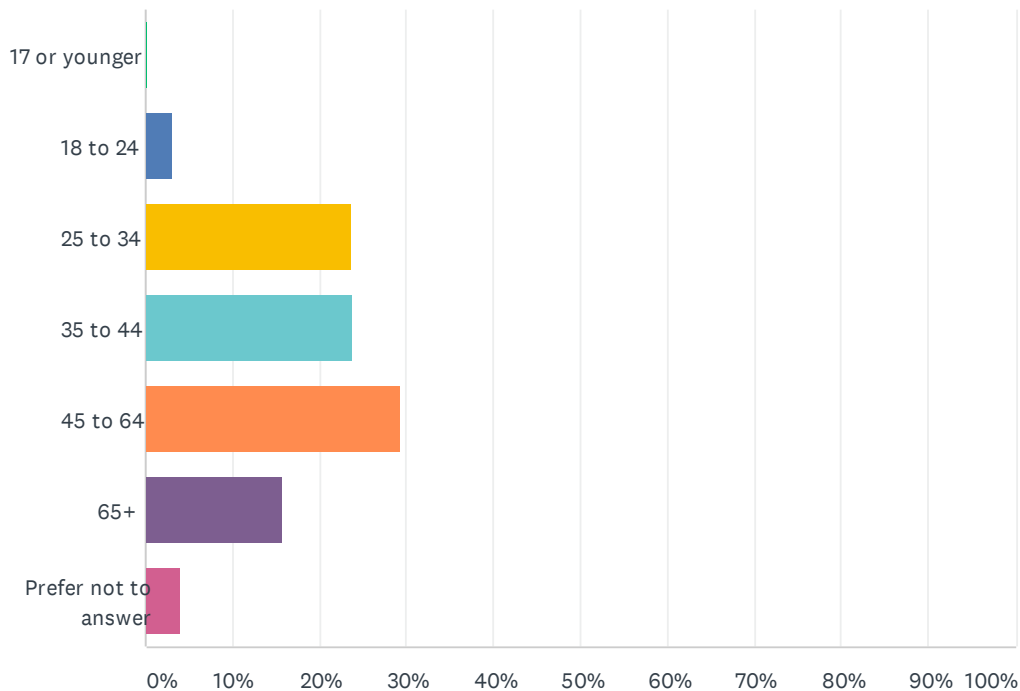

Q11 What is your age?

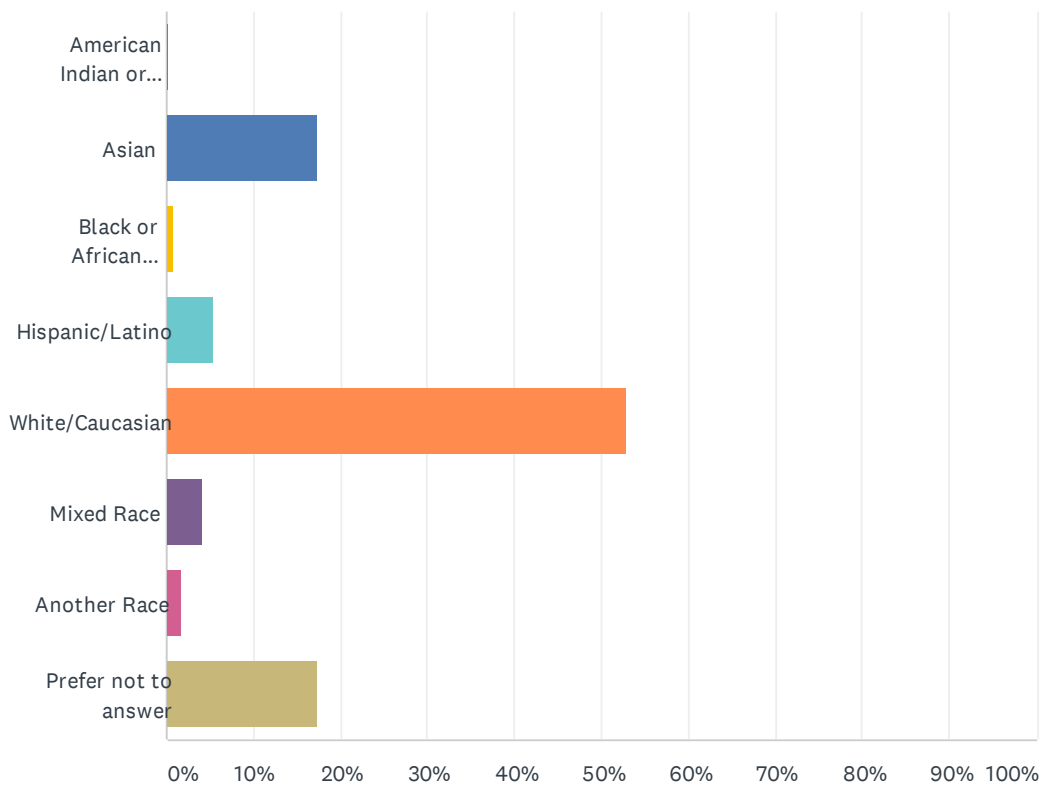

And why stop at multi-unit residences. A parent who smokes in a single family home is harming their children. Single family homes are so close to each other in California, that if the adult smokes outside, the smoke is likely waft into a neighboring home. If the problem is smoke wafting into neighboring units, set better standards for building multi-unit dwellings. On the other hand, outdoor common areas have much in common with public areas and prohibiting smoking outdoors should be considered outdoors. In summary, the indoor ban would be a well meaning but misguided effort much like prohibition in the 1920s. Air quality is important to me, and to me the most significant threat to our everyday air quality is gas-powered leaf blowers. The fumes are horrendous, whether walking by a property where a gas-powered leaf blower is in use, or in an apartment with all the windows closed and an active leaf blower is just a few feet way from a closed window. We know that the smog-producing emissions of gas-powered leaf blowers disproportionately cancel out the gains we have made in auto emissions. Without addressing the use of gas-powered leaf blowers, it makes no sense for Mountain View to support the adoption electric vehicles. Thus any multi-unit smoking ban must also forbid the use of gas-powered leaf blowers. While single family dwelling owners can control whether gas-powered leaf blowers are used on their property, residents of multi-unit properties cannot. posed by tobacco and marijuana smoking. Mountain View might consider a multi-unit gas-powered leaf blower ban a less drastic ban than a similar city-wide ban. Later, after successfully implementing a targeted gas-powered leaf blower ban, the city and leaf-blowing providers would be better prepared to adopt a city-wide ban. The results would be dramatic. With regards to banning cigarette and marijuana smoking in multi-unit dwellings, it seems somewhat arbitrary. As mentioned, fumes from gas-powered leaf blowers still might be permitted. Barbecues would be permitted, as would frying, and cooking with spices. All these activities produce fumes that some people find unhealthy or otherwise objectionable. The arbitrariness of such a ban is concerning. With regards to banning the smoking of tobacco, that would be a big imposition on smokers, given that most are addicted to nicotine. Where would they be allowed to smoke? On the side walk? The city might consider, if choosing to establish such an ordinance, that existing tenants be exempt, so that they would not be forced to move. All new move-ins would commence with a full anti-smoking ban in place.
