Board member Tang inquired about *rainbow fentanyl* regarding how real the threat is with input from Police Captain Mike Canfield.

Board member Brodovsky echoed concern about Measure C enforcement and asked a clarifying question. Assistant City Manager/Chief Operating Officer Audrey Seymour Ramberg gave input.
