A RESOLUTION AMENDING THE CITY OF MOUNTAIN VIEW  
MASTER FEE SCHEDULE RELATED TO CANNABIS BUSINESS REGULATIONS

WHEREAS, staff has reviewed and analyzed the cost of providing various City services and allocated overhead costs throughout the City departments; and

WHEREAS, the City seeks to achieve and maintain financial stability through reasonable cost recovery where appropriate to allow the City to continue to provide cost-effective services; and

WHEREAS, in connection with the development of cannabis business regulations, it is necessary for the City to adopt fees to ensure cost recovery for administration and enforcement costs; and

WHEREAS, the schedule of fees is reasonably related to the impacts and service needs created by cannabis businesses;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View:

1. The following fees are hereby adopted as set forth in the schedules attached hereto and incorporated herein:
