5.1 Google Middlefield Park Master Plan

Recommendation: Discuss and provide input on the proposed master plan on a 40-acre site generally located on the northeast corner of Ellis Street and East Middlefield Road in the East Whisman Precise Plan area to include 1,675 to 1,900 residential units, 1.2 to 1.3 million square feet of office, 50,000 square feet of ground-floor commercial space, up to 10.5 acres of parks, a private utility district to serve the site, two parking structures, new private streets, and bicycle/pedestrian improvements.

5.2 555 West Middlefield Road Residential Project

Recommendation: Discuss and provide input on the proposed project located on a 14.5-acre site bounded by West Middlefield Road, Moffett Boulevard, Cypress Point Drive and State Route 85, which includes General Plan

and Zoning Map Amendments and a Planned Community Permit and Development Review Permit to allow a 329-unit addition to an existing 402-unit residential development and a new 1.34-acre public park.

ADDRESSING THE COMMISSION:

Interested persons are entitled to speak on any item on the agenda and should make their interest known to the Chair.

Anyone wishing to address the Commission on a nonagenda item may do so during the Oral Communications portion of the agenda. Speakers are allowed to speak one time on any number of topics for up to three minutes.

An individual speaker shall have up to 3 minutes to address the Commission. For any agenda item or for Oral Communications on nonagenda items, if there appears to be a large number of speakers, the Chair may reduce speaking time to no less than 1.5 minutes per speaker unless there is an objection from Commission by majority vote.

Pursuant to Government Code Section 54954.3(b)(1), at least twice the allotted speaking time will be provided to a member of the public who utilizes a translator.
