**NOTICE OF PUBLIC HEARING
 RECOMMENDED TRASH/RECYCLING/
 ORGANICS RATES EFFECTIVE JULY 1, 2022**

**City of Mountain View City Council Chambers
 500 Castro Street, Second Floor
 Tuesday, June 28, 2022, at 6:30 p.m.
 or as soon thereafter as the matter can be heard.**

The City of Mountain View (City) takes pride in providing water, wastewater (sewer), and solid waste (trash, recycling, and organics) services at the lowest rates possible. In general, the City's rates are comparable to or lower than those of neighboring cities. The purpose of this letter is to alert our customers that there are recommended increases to utility rates to be considered and included at a public hearing on June 28, 2022.

Rate increases are generally necessary to pay for the higher costs the City will be charged by: the San Francisco Public Utilities Commission (SFPUC) and the Santa Clara Valley Water District (SCVWD) for the water they supply to the City; the Palo Alto Regional Water Quality Control Plant (Treatment Plant) for the treatment of the City's wastewater; Recology for trash, recycling, and organics collection services and certain processing services; and the Sunnyvale Materials and Recovery Transfer (SMaRT®) Station for processing commercial and residential trash and residential recyclables. This letter provides the details of the recommended rate increases for Fiscal Year 2022-23 beginning on July 1, 2022 (the City's fiscal year is from July 1 through June 30). No Proposition 218 hearing is required for water and wastewater rates as those rate increases are within the previously adopted schedule of fees, and pass-through and inflationary adjustments approved at a public hearing on June 22, 2021 pursuant to Government Code Section 53756. The rates in this notice are monthly rates; the City bills customers on a bimonthly basis.

In summary, for a typical single-family residence, the Fiscal Year 2022-23 recommended rate increases are:

Water—12.0%
 Sewer—8.0%
 Trash/Recycling/Organics—6.0%

TRASH AND RECYCLING RATES

Effective July 1, 2022, a 6.0% rate increase is recommended (rounded up to the next five cents) for trash/recycling/organics services, which consists of the Recology increase, SMaRT Station net cost increases, and City cost increases.

Recology is the private company that provides trash, recyclables, and organics collection services in the City. The City's recently updated contract with Recology provides for a 3.38% increase in collection services based on the Consumer Price Index for All Urban Consumers in the San Francisco Metropolitan Area as published by the U.S. Department of Labor, Bureau of Labor Statistics (CPI), for the annual change in December. The updated agreement included significant changes that went into effect January 2022, whereby residential organics (food waste), construction and demolition (C&D), and source-separated (SS) recycling are no longer delivered to the SMaRT Station for processing, but delivered to specialized facilities for processing.

The City's residential trash, residential recyclables, and commercial trash are processed at the SMaRT Station under a Memorandum of Understanding (MOU) between the City of Mountain View and the City of Sunnyvale. This MOU was updated during the last fiscal year with the above-mentioned significant changes in processing effective January

2022. The MOU provides for the City to pay its proportional share of costs, and, while the City’s share of SMaRT Station costs are approximately 2.4% lower for Fiscal Year 2022-23, after taking into consideration the change in processing services, costs are estimated to increase 1.0%.

These changes were made in an effort to reduce the amount of waste sent to landfills as well as to abide by Senate Bill 1383, which mandates residential and commercial organics composting. City operating costs are increasing approximately 23.0%, primarily due to these changes, and, as a result, trash/recycling/organics rates would need to increase approximately 15.0% to maintain a balanced operating budget. However, there is sufficient available fund balance to smooth this rate increase over three fiscal years. Accordingly, a 6.0% increase for trash/recycling/organics rates is recommended for Fiscal Year 2022-23, with the remainder spread over the following two fiscal years. See below for the sample recommended rates and Exhibit 1 for a complete list.

This is a sample calculation of recommended rates based upon the recommended rate increase above.

The trash/recycling/organics rates stated in this notice will not be increased above the rates stated above without further written notice to the City’s customers and a further protest hearing pursuant to Proposition 218.

PROTESTS

Article XIII(D) of the California State Constitution, also known as Proposition 218, allows utility customers to submit written protests to the City regarding recommended rate increases. Utility customers objecting to the recommended trash/recycling/organics rates described in this notice may file written protests with the City Clerk. No email protests are accepted. Protests must be received before the close of the public hearing on June 28, 2022. Written notices should be addressed as follows:

Protests may also be submitted in person at the City Clerk’s Office at City Hall (500 Castro Street—3rd Floor) before 5:00 p.m. on June 28, 2022, dropped in the Utility payment mail slot on the side of City Hall between the main doors and Castro Street before the close of the hearing on June 28, 2022, or at the public hearing should the hearing be in person. Pursuant to California Government Code Section 53755(b), only one written protest per parcel filed by a property owner or utility customer of the parcel who is responsible for paying the rates will be counted to determine whether or not there is a majority protest to the recommended rate increases. To be included in the protest count, a protest must be signed and include the address of the utility customer submitting the protest, or, if submitted by a property owner who is not a utility customer, the service address; be timely; be submitted with respect to a property served by the City’s utilities; and state that it is protesting the recommended trash/recycling/organics rate increase.

NOTICE OF WATER AND WASTEWATER RATE CHANGES—NO PROPOSITION 218 HEARING REQUIRED

WATER RATES

Effective July 1, 2022, a 12.0% increase is recommended for the average cost of water and meter rate (rounded up to the next cent and five cents, respectively), which consists of City cost increases up to the Consumer Price Index (CPI) inflation adjustment and wholesale supplier increase.

Effective July 1, 2022, the recycled water rate is recommended to increase by CPI (rounded down to 5.0%) from \$5.05/unit to \$5.31/unit (rounded up to the next cent) to cover the cost of the program.

The SFPUC has notified the City of a proposed 15.9% increase in wholesale rates effective July 1, 2022, and its public hearing is generally held in May to adopt rates. The SCVWD has notified the City of a proposed 15.6% increase in the well water rate for Fiscal Year 2022-23, which corresponds to a 14.5% increase in the treated water rate as it is based on the well water rate plus \$115.00 per acre-foot surcharge. The SCVWD’s public hearing process concludes April 26, 2022. The CPI for All Urban Consumers in the San Francisco Metropolitan Area for February 2022 is 5.2%. The combination of increases from the SFPUC and SCVWD and CPI increase for City costs results in an approximate 12.2% rate increase, and a 12.0% rate increase is recommended within the inflationary and pass-through rate increase provisions allowed and approved at a public hearing June 22, 2021 pursuant to Government Code Section 53756. WASTEWATER (SEWER) RATES

Effective July 1, 2022, a total 8.0% rate increase is recommended (rounded up to the next five cents for the residential flat rate and to the next cent for the per-unit rate), which consists of the Treatment Plant increase, CPI inflation adjustment, and a 2.0% increase (Year 9 of a 10-year phase-in period) to fund future major renovations at the Treatment Plant.

The City of Palo Alto notified the City of a 6.8% proposed increase in its Treatment Plant budget for Fiscal Year 2022-23. Wastewater rates paid by Mountain View customers fund the cost of treating wastewater generated in the City at the Treatment Plant (approximately 60.0% of costs) and costs to operate the City’s sewer system (approximately 40.0% of costs). The CPI for All Urban Consumers in the San Francisco Metropolitan Area for February

2022 is 5.2%. The combination of the supplier and CPI increases result in an approximate 6.1% rate increase, and a 6.0% increase is recommended within the inflationary and pass-through rate increase provisions allowed and approved at a public hearing June 22, 2021 pursuant to Government Code Section 53756. An additional 2.0% rate increase for future major renovations at the Treatment Plant (Year 9 of a 10-year phase-in period) was also noticed and approved at the June 22, 2021 public hearing.
