Good day Council members:

I understand that you guys are holding a closed session tonight to discuss Measure C.

First of all, it is unacceptable that you are holding a closed session on a Project that was approved by the voters. I can only suspect that something is being discussed that you do not want the voters to know about. At this time of mistrust in government and the ridiculous delays that have already occurred on this project, this move on your parts not only violates the voters trust, but also the transparency that we, the citizens of Mountain View deserve and demand from our elected Council members. And I am talking about all the citizens of Mountain View, not just those who voted "yes" on Measure C.

My guess is that the intent of the closed-door meeting tonight is to either discuss the implications of the lawsuit, and/or to discuss delaying or somehow overruling the Measure C project.

I strongly encourage the Mayor to cancel this closed-door meeting immediately and reschedule it as part of the next session's agenda so the public can hear the discussion and have the transparency they deserve.

Secondly, I believe the Council or City cannot overrule a Measure that was approved by the voters in a special election that cost the voters a large amount of money and was unanimously approved.

Thirdly, any additional efforts to delay the implementation of the Measure C sign project will be met with fierce protests, possible recall of Council members or a potential suit against the City.

Just so you are aware of it, I have personally been investigating the Measure C installation project for the last two weeks. I have used freedom of information to request detailed information not only on the status of the project but how it has been managed and carried out. So far, it is obvious to me that something has happened since January of this year to cause multiple delays in the start of the project including allowing a lawsuit to be filed against Measure C. This has led me to become suspicious that 1) there may have been things going on behind the scenes to cause these delays that have not been fully disclosed or 2) the project may have been totally mismanaged. Once I receive final information that I need, I may be raising a

complaint against the City of project mismanagement and non-transparency on the part of the City both to subvert the completion of the project and delay.

We are very serious about this and respectfully request that all of you do your job and make sure that the will of the voters is carried out immediately and completed ASAP. Otherwise there will be serious ramifications.

I expect to receive emails from each of you that include details of what transpired and any decisions that were made. If a private vote is taken, I demand to know what it was on and how each Council member voted. Remember - transparency!
