Hello Council Members,

We are residents of Mountain View and are writing to you today to urge your SUPPORT of the ordinance requiring the Safe Storage of Firearms in Residences and Vehicles in Mountain View. Having raised children in the City of Mountain View, this ordinance is important to us because:

- Nearly every day in this country one small child unintentionally kills himself or another child after finding an unsecured firearm typically in their home.
- Every day on average, two teens commit suicide using an unsecured firearm from their home or a relative's home.
- 80% of school shootings are done by a student or former student of the school, using an unsecured firearm obtained from their home or a relative's home.
- A Safe Storage ordinance has become more urgent than ever during Covid, given the dramatic rise in gun sales. We have seen a shocking 43% increase in unintentional deaths of small children and a 9% increase in teen suicides.
- Research shows that keeping guns securely stored does NOT hinder self-protection- a gun can be accessed within seconds- but it DOES prevent unintentional deaths of children and teen suicides, by as much as 85% depending on the type of storage.
- American children are nearly twice as likely to be shot and killed as they are to die by drowning. Yet safety regulations for pools are far more pervasive and restrictive than those for guns.
- Parents often hide their guns rather than locking them up, but studies show 70% of children know the location of these hidden guns in their own home and many have even handled them.
- Many cities in our county have already adopted Safe Storage ordinances, including Los Altos, Los Altos Hills, Palo Alto, Monte Sereno, Morgan Hill, Saratoga and San Jose. I hope that Mountain View will do the same.

We appreciate your consideration of this important issue.

Dear Members of the Mountain View City Council:

Tonight you will be considering an ordinance requiring the safe storage of firearms in residencies and vehicles. As a trauma surgeon in your area, I strongly recommend that Mountain View join with Palo Alto, Los Altos, and Los Altos Hills in passing such an ordinance to help keep our citizens safe. Just yesterday a new scientific article documented the tragic toll on children from firearm injuries during the pandemic, primarily from guns found in homes that were not secured. Similarly, elderly and depressed men and women often turn to guns to end their life during times of severe depression. Both suicides and accidental gun deaths and injuries can be easily prevented by locking away guns and keeping ammunition in a separate locked container. These small measures can save lives immediately. I hope you will strongly support the passage of this ordinance as a measure to improve the health and safety of our community.
