RECOMMENDATION

BACKGROUND AND ANALYSIS

"Acceptance" of developer-installed improvements signifies that the developer has satisfactorily completed improvements in the City's right-of-way. Once accepted, the City takes ownership of and maintenance responsibility for the improvements.

1075 Terra Bella Avenue

This development project included a new two-story, 19,285 square foot office building. The public improvement plans for the project were approved for construction on February 20, 2020.
