#### 5. PUBLIC HEARING

**5.1 749 W. El Camino Real - Mixed Use Residential**

**Recommendation:** Request for a Planned Community Permit and Development Review Permit to remove an existing commercial bank building, a vacant restaurant building and surface parking lot and construct a mixed-use development comprised of 299 residential rental units, utilizing State Density Bonus Law, in a six-story building with 10,830 square-feet of ground-floor neighborhood commercial space and at grade podium parking above two levels of underground parking; a two-story 8,483 square-foot bank building; a Provisional Use Permit for a rooftop deck; and a Heritage Tree Removal Permit to remove 28 Heritage Trees; and a Vesting Preliminary Parcel Map to create a single lot with up to four commercial condominium units from two existing parcels on a 3.05-acre site. An Environmental Impact Report (EIR) was prepared for the project pursuant to Sections 15121(a) and 15152 of the California Environmental Quality Act Guidelines. This project is located on the southeast corner of West El Camino Real and Castro Street in the P(38) El Camino Real Precise Plan.

**Recommendation:** That the Environmental Planning Commission Recommend the City Council Adopt an Ordinance of the City of Mountain View Repealing Chapter 36, Article XIII (Tenant Relocation Assistance) of the Mountain View City Code, Amending Chapter 46 of the Mountain View City Code to change the Title and add a new Article Governing Tenant Relocation Assistance, and Finding that these Code Amendments are not subject to the California Environmental Quality Act.

Anyone wishing to address the Commission in person must complete a yellow speaker card indicating the name you would like to be called by when it is your turn to speak and the item number on which you wish to speak. An individual speaker shall have up to three minutes to address the Commission. For any agenda item or for Oral Communications on nonagenda items, if there appears to be a large number of speakers, the Chair may reduce speaking time to no less than 1.5 minutes per speaker unless there is an objection from the Commission by majority vote.

If requested in advance of the public input portion of the agenda item to the Chair or dais staff, a speaker who represents five or more members of the public in attendance who complete cards but elect not to speak may have up to 10 minutes to address the Commission, if the Chair determines that such extension will reduce the total number of speakers who planned to speak.

An applicant and/or appellant for a zone change, precise plan or quasi-judicial hearing shall have up to 10 minutes to address the Commission and, with the consent of the Commission, two minutes of rebuttal at the conclusion of all public speakers.

The presiding officer may remove or cause the removal of any individual(s) for disrupting a meeting in accordance with California Government Code section 54957.95, as may be amended from time to time. In accordance with California Government Code section 54957.9, as may be amended from time to time, the Commission may order a meeting room cleared and continue in session in the event a meeting is willfully interrupted by a group or groups of persons so as to render the orderly conduct of the meeting impossible, and order cannot be restored by the removal of individuals who are disrupting the meeting.
