MOTION - MS - Rosenberg/Showalter - to Introduce an Ordinance Amending Chapter 2, Article XII of the Mountain View City Code, Related to Campaign Disclosure Requirements and the Voluntary Expenditure Limits, to be read in title only, further reading waived, and set second reading for April 24, 2018 (Attachment 1 to the Council report), with added language to Section 2.106.b as follows: "If any disclosed contributor is a committee, the top three

contributors who contributed \$2,500 or more to that contributing committee must also be disclosed."
