A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW  
AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ACCEPT A GRANT IN THE  
AMOUNT OF \$102,000 FROM DESTINATION: HOME SV TO SUPPORT THE CITY'S  
ONGOING AND NEW HOMELESS INITIATIVES, AND AUTHORIZING THE CITY MANAGER  
OR THEIR DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY FOR RECEIPT  
OF THE GRANT FUNDS

WHEREAS, on June 8, 2021, the City Council authorized acceptance of a grant from Destination: Home in the amount of \$450,000 to be equally distributed for three fiscal years beginning Fiscal Year 2021-22; and

WHEREAS, on June 8, 2021, the City Council authorized the City Manager or designee to execute an agreement with Destination: Home, a supporting organization of Silicon Valley Community Foundation, to receive the grant amount of \$450,000 in support of the City's ongoing and new initiatives that align with the Santa Clara County Community Plan to End Homelessness and the City's Homeless Response Strategy Implementation and Expenditure Plan; and

WHEREAS, on June 24, 2021, the City of Mountain View and Destination: Home entered into a grant agreement to support the City for ongoing and new initiatives that align with the Santa Clara County Community Plan to End Homelessness and the City's Homeless Response Strategy and Expenditure Plan; and

WHEREAS, on September 17, 2024, the City of Mountain View sought additional funding from Destination: Home requesting a grant in the amount of \$102,000 to support the Community Services Agency (CSA) in continuing critical case management, housing information and referral services, and focused outreach and housing assessment services; and

WHEREAS, on January 23, 2025, Destination: Home, via the Silicon Valley Community Foundation, awarded the City of Mountain View a grant in the amount of \$102,000 to provide critical case management, housing information and referral services, and targeted outreach for Mountain View's unhoused and unstably housed residents; now, therefore, be it

RESOLVED: that the City Council of the City of Mountain View hereby authorizes the City Manager or their designee to accept a grant in the amount of \$102,000 from Destination: Home SV to support the City's ongoing and new homeless initiatives; and be it

FURTHER RESOLVED: that the City Manager or their designee is authorized to execute all documents necessary for receipt of the grand funds from Destination: Home SV; and be it

FURTHER RESOLVED: that this Resolution shall become effective immediately upon adoption.
