REGULAR MEETING—WEDNESDAY, NOVEMBER 12, 2025 ATRIUM CONFERENCE ROOM—500 CASTRO STREET 6:00 P.M.

1. CALL TO ORDER

6. UNFINISHED BUSINESS

6.1 CAPITAL IMPROVEMENT PROGRAM PUBLIC ART PROJECT UPDATES

Staff provided an update on the public art contracts for public art at Evelyn Park, Villa-Chiquita Park, Rengstorff tennis and maintenance buildings, and Shoreline Boathouse.

6.2 UPDATE AND DISCUSSION ON PUBLIC ART STRATEGY EFFORTS

Amanda Rawson with consulting firm Art Builds Community presented on the efforts to engage the community and develop a public art strategy. Staff asked the Visual Arts Committee (VAC) to provide feedback on the draft strategy that they had developed, including whether staff should consider any changes in priority.

The VAC's feedback was to continue building on the draft strategy. Additional comments included:

- Reviewing the VAC 2023 draft vision statement and the City Council October 2024
 Study Session vision statement against the goals and strategies.
- Consider how we can add more functional art, such as bike racks.
- Consider how public art can be included when the Downtown Castro Street Pedestrian Mall is redone.

6.3 VISUAL ARTS, DOWNTOWN, PERFORMING ARTS AD HOC SUBCOMMITTEE UPDATE

Staff and subcommittee members Sakols and Spaid provided an update on the Visual Arts, Downtown, and Performing Arts ad hoc subcommittee efforts to plan a pilot artist reception on February 17, 2026 with artist Donald Hershman.

7.1 AUTHORIZE 2025-26* CALL FOR ARTIST EXHIBITIONS

Staff asked the committee to discuss the upcoming 2026-27 Call for Artist Exhibitions at the Mountain View Center for Performing Arts. VAC requested to share the call for artists with local schools, including Freestyle Academy, to invite any students who have materials to apply for the upcoming year and to consider a future collaboration for a student-led exhibit.

Lacy Rathbun inquired about the process for painting or adding art to the Permanente Creek trail bridge near Crittenden School.

Staff provided the following updates:

- Senate Bill 456, exempting muralists from Contractor State Licensing Board requirements, passed in September 2025, effective January 1.
- The Bollard Beautification project will be reinstated in the new year.

 The Train Depot art project with Arts Mountain View continues; it requires collaboration across multiple entities, including Valley Transportation Authority and CalTrain. Installation is expected to occur early in the new year, weather permitting.
