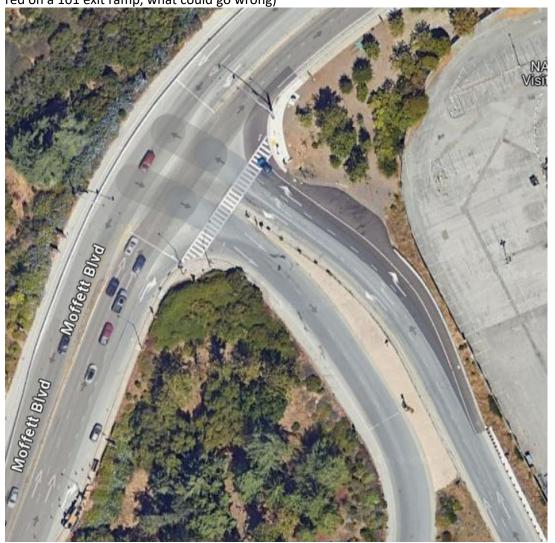

Dear City Council,

Having biked to work on Moffett off and on since I first interned on the other side of the fence, I'm really excited about the Moffett Boulevard Complete Streets project. This project represents a major opportunity to increase safety for everyone who bikes or walks to Moffett Field—whether they be people who live on-site, interns and students living here temporarily without a car (both demographics which I would expect to increase with planned developments like the Berkeley Space Center), or employees like me who bike to work.

Right now, biking on Moffett over highway 101 requires nerves of steel because the bike lanes are in the middle of travel lanes and cyclists must ride unprotected mere feet from cars. For me, it is the least safe part of my commute, and I hope this project will effectively solve this problem while improving access for cyclists and pedestrians.

With that in mind, given the rather minimal description in the staff memo, I hope that the project will include a broader scope than what is written. Within the project area, there is an opportunity to totally deconflict bicycle and roadway traffic by creating a two-way cycletrack on the north side of 101, close more sidewalk gaps than listed, adjust signalization, and change the northbound highway 85 entrance into a safer, signalized, "no right on red" turn lane, and I hope all of these improvements could potentially be pursued in the course of the project.

Finally, I hope that, concurrently with this project, the city will address the lack of bike lanes on Moffett Boulevard between the Caltrain Station and Middlefield. Many of my coworkers would like to be able to ride from the Caltrain to Moffett Field and would benefit from a visible, obvious, and direct route on Moffett Boulevard, which would require continuing the bike lanes only 3 more blocks. I realize that there are other projects in this area, such as the Grade Separation project ("interim" and long-term) and the Moffett Precise Plan. However, the schedule and scope of these projects is uncertain to me, and I hope that the council will push to provide a complete bike route here sooner rather than later.

I am very thankful that the city is committed to addressing pedestrian safety and access in this area and I hope to be able to engage more with this project in the future as it comes to fruition.
