A RESOLUTION AMENDING THE CITY OF MOUNTAIN VIEW
MASTER FEE SCHEDULE TO MODIFY MASSAGE FEES

WHEREAS, the Massage Therapy Act, Business and Professions Code Section 4600, was amended in 2014, and the City wishes to provide minimum standards for the operation of massage establishments and restrict the commercial practice of massage in the City to those persons duly certified to practice by the California Massage Therapy Council (CAMTC) formed pursuant to the Massage Therapy Act; and

WHEREAS, the City is responsible for assessing and collecting fees for permits and services related to these activities;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View that the following fees are hereby adopted as set forth in the schedule attached hereto and incorporated into the Master Fee Schedule as:
