We are pleased to see that Midpeninsula Housing Coalition is able to expand the number of affordable units at its 460 N. Shoreline Boulevard location since the cost of acquiring land in Mountain View has become so expensive.

The concept of adding 50 additional affordable units to the present development, all targeted to those below 60% area median income, while only displacing 12 households temporarily, is a wonderful opportunity to create new affordable housing. We are pleased that the tenants temporarily displaced will have the right to return to a new unit and, according to the staff report, the relocation support appears to be sufficient for these displaced households.
