### 1. CALL TO ORDER

Mila Zelka asked the City to consider the organization Manzanita Works as a potential community partner to work toward transportation mode-shifts in the City.

Giulianna Pendleton encouraged the City to address light pollution, particularly related to LED lights.

Shani Kleinhaus spoke about light pollution and proposed creating new maximums for lighting to conserve energy and address light pollution, possibly through a City ordinance.

Gita Dev encouraged the City to display sustainability metrics for the public to track progress toward goals and encouraged more interdepartmental coordination on sustainability to support green streets.

Bruce England spoke in support of induction stovetops and creating a program to buy or rent them cheaply as well as tracking how many are being used by the community.

Kevin Ma discussed the VTA budget and encouraged shifting dollars away from highway improvements and toward transit and active transportation projects and programs.

Bruce Naegel encouraged the City to track and display sustainability metrics that are grounded in the City's goals and show what actions are proving successful.

Hala Alshahwany spoke about the City's ongoing removal of Heritage trees for various projects and asked for more thorough tracking of the number of trees removed, the number of trees planted, and overall canopy coverage in Mountain View.
