- 2. Approve the remaining five local emissions-reduction actions to be included in the model, bringing the total to ten local actions.
- 3. Direct staff and Cascadia (the project team) to develop a five-year decarbonization roadmap focused on achieving the 2045 decarbonization goal already adopted by the City Council for review at a future CSC meeting and ultimate adoption by the City Council.
