A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
AMENDING CITY OF MOUNTAIN VIEW RESOLUTION NO. 18596, WHICH APPROVED
AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT FROM
THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM—CORONAVIRUS RESPONSE
AND/OR THE 2020-2021 FUNDING YEAR OF THE STATE CDBG PROGRAM,
TO PROVIDE FLEXIBILITY IN THE ALLOCATION OF THE GRANT FUNDS BETWEEN
THE TWO ACTIVITIES APPROVED FOR FUNDING BY
THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT

WHEREAS, on August 24, 2021, the City Council adopted Resolution No. 18596 as required by the California Department of Housing and Community Development (HCD) to authorize submission of a grant application for \$5 million in Community Development Block Grant (CDBG) Homekey funding for LifeMoves to undertake two activities to support the interim housing project at 2566 Leghorn Street; and

WHEREAS, there are two HCD-approved activities to be funded by the \$5 million grant: (1) the purchase and installation of a solar panel system for the interim housing project; and (2) the acquisition and improvement of the 1950 Leghorn Street site to provide additional parking for the interim housing project; and

WHEREAS, Section 1 of Resolution No. 18596 states that \$5 million in grants funds would be allocated between the two HCD-approved activities as follows:

Solar Power System Purchase and Installation—\$1,000,000; and

Site Acquisition for Additional Parking—\$4,000,000.

WHEREAS, the cost to complete the two activities has increased significantly since the date Resolution No. 18596 was adopted and, therefore, the budget for and allocation of grant funds between each activity must be modified; and

WHEREAS, the HCD has advised that the allocation of the \$5 million in CDBG Homekey grant funds between the approved activities may be modified and that the City Council should adopt a resolution authorizing allocation of the grant funds between the approved activities as necessary; now, therefore, be it

RESOLVED: that the City Council of the City of Mountain View hereby amends Section 1 of Resolution No. 18596 to delete the \$1,000,000 and \$4,000,000 budget amounts for the two HCD-

approved activities, to authorize use of the CDBG Homekey funding in a total amount not to exceed \$5 million for the two HCD-approved activities, and to authorize allocation of the \$5 million in CDBG Homekey funding between the two HCD-approved activities as necessary for completion of each activity.

The foregoing resolution was regularly introduced and adopted at a Regular Meeting of the City Council of the City of Mountain View, duly held on the 27th day of June 2023, by the following vote:




