# **BACKGROUND AND ANALYSIS**

As set forth in Mountain View City Code Section 2.1, City Council Regular Meetings are held on the second and fourth Tuesdays of the month. The following schedule proposes minor modifications to the City Council's regular schedule to avoid observed holidays and provide for a summer recess and a winter recess. City Council Special Meetings have been included to accommodate the Thanksgiving and Christmas holidays and to anticipate board, commission, and committee interviews and the Council appointees' annual review.

Councilmembers attending conferences that overlap with a Council meeting may avail themselves of the provisions of <u>Government Code 54953</u> to attend the meeting using the "just cause" provision as long as the Councilmember participates through both audio and visual technology and publicly discloses at the meeting before any action is taken whether any other individuals 18 years of age or older are present in the room at the remote location and the general nature of the member's relationship with any such individuals. Use of this provision is limited to two meetings per calendar year.
