**TITLE:** **Cost-Sharing Agreement with the City of Los Altos for Annual Street Resurfacing and Slurry Seal Program, Project 18-01**

### **RECOMMENDATION**

Authorize the City Manager to execute a cost-sharing agreement with the City of Los Altos for pavement rehabilitation on El Monte Avenue and Grant Road for an amount not to exceed \$160,000.

### **BACKGROUND**

Each year, the City of Los Altos performs its annual pavement and slurry seal program to resurface selected streets. This year, the program includes El Monte Avenue and Grant Road bordering Mountain View. The City of Los Altos has offered to partner with Mountain View to complete portions of the proposed work on El Monte Avenue and Grant Road within Mountain View's right-of-way to provide a logical limit of work.

### **ANALYSIS**

Portions of both El Monte Avenue and Grant Road are split by the City limit between Los Altos and Mountain View (see Attachment 1). Performing the street rehabilitation as part of the City of Los Altos project will provide a uniform street surface and take advantage of the economy of scale of a larger project. The project will consist of base repair of failing pavement sections, slurry sealing, and pavement striping.

The City of Los Altos has completed the plans and specifications, advertised the project for bids, and will award the contract to the lowest responsible bidder. Construction is expected to start in July 2017. Per the proposed agreement, Mountain View would reimburse Los Altos for construction costs based on the actual work and quantities constructed within Mountain View City limits.

The estimated cost of Mountain View's portion of the work, including construction, construction management, and construction contingency, is \$138,000.

As the City of Los Altos will open bids in mid-June and construction is scheduled to start in the summer while Council is not in session, staff recommends Council authorize the City Manager to execute an agreement in an amount up to \$160,000 in case bids are higher than estimated. If the cost is higher based on the bid amount, staff recommends the City not participate in the project.

### **FISCAL IMPACT**

Funding is recommended from the 2017-18 Annual Street Resurfacing and Slurry Seal Program, Project 18-01, which is proposed for funding on July 1, 2017 with a budget of \$1,569,000. If the project is funded as expected, there will be sufficient funding for the recommended actions.

### **ALTERNATIVES**

1. Do not participate in the project.
2. Provide other direction.
