A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION
OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO
FROM THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT
PROGRAM—CORONAVIRUS RESPONSE AND/OR
THE 2020-21 FUNDING YEAR OF THE
STATE COMMUNITY DEVELOPMENT BLOCK GRANT HOMEKEY PROGRAM

BE IT RESOLVED by the City Council of the City of Mountain View as follows:

Section 1. The City has reviewed and hereby approves the submission to the State of California of one or more applications in the aggregate amount of, not to exceed, \$5 million for: (i) the following Community Development Block Grant (CDBG)—Coronavirus Response activities pursuant to the CDBG Method of Distribution as described in the State of California 2019-2020 Annual Action Plan August 2020 Second Substantial Amendment; and/or (ii) the following CDBG activities pursuant to the CDBG Method of Distribution as described in the State of California 2020-2021 Annual Action Plan January 2021 Substantial Amendment:

Site Acquisition for Additional Parking to Support Mountain View Homekey	4,000,000
TOTAL	\$ <u>5,000,000</u>

<u>Section 2</u>. The City hereby approves the use of Program Income in an amount not to exceed \$0 as no Program Income funding is available for the CDBG—Coronavirus Response activities and/or CDBG activities described in Section 1.

<u>Section 3</u>. The City acknowledges compliance with all State and Federal public participation requirements in the development of the City's application(s).

<u>Section 4</u>. The City hereby authorizes and directs the City Manager or designee to execute and deliver all applications and act on the City's behalf in all matters pertaining to all such applications.

<u>Section 5</u>. If an application is approved, the City Manager or designee is authorized to enter into, execute, and deliver the grant agreement (i.e., Standard Agreement) and any and all subsequent amendments thereto, with the State of California for the purposes of the grant.

<u>Section 6</u>. If an application is approved, the City Manager or designee is authorized to sign and submit Funds Requests and all required reporting forms and other documentation, without limitation, including any covenant or regulatory agreement as may be required by the State of California from time to time in connection with the grant.

<u>Section 7</u>. Pursuant to City Council Policy No. A-10, "Authorization to Execute City Contracts and Agreements and Increase Certain Limited Appropriations," the City Manager has the authority to designate in writing a representative to exercise the City Manager's authority to execute City contracts and agreements.
