A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
 AMENDING RESOLUTION NO. 18533 DESIGNATING 34 STREETS, OR PORTIONS THEREOF,
 WHERE OVERSIZED VEHICLE PARKING ON NARROW STREETS IS PROHIBITED
 PURSUANT TO MOUNTAIN VIEW CITY CODE SECTION 19.79.4

WHEREAS, Chapter 19 of the Mountain View City Code prohibits and restricts parking under various circumstances; and

WHEREAS, Section 19.79.4 of the Mountain View City Code provides that no person shall park an oversized vehicle on narrow streets, as set forth by Council resolution; and

WHEREAS, in accordance with Mountain View City Code Section 19.79.4, the City Council desires to add streets, or portions thereof, to table 19.79.4, as previously adopted in Resolution No. 18533, to prohibit oversized vehicle parking on narrow streets;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mountain View that pursuant to Mountain View City Code Section 19.79.4, the parking of oversized vehicles on narrow streets is prohibited at the additional locations designated below to be added to Table 19.79.4:
