Don Letcher stated that while he agreed with a majority of Mr. Siegel's concerns, he does not approve of housing in North Bayshore, with the exception of the Moffett Field area.

Jennifer Couperus spoke in opposition to developing housing in the North Bayshore area.

Aldona Majorek expressed concerns with the housing deficit and in support of developing residential housing in the North Bayshore area.

Esteban Guerrero, a Stanford University grad student, offered strategic analysis and problem solving assistance, as a class project, to the City.
