5. **NEW BUSINESS**

5.1 PRESENTATION ON CLIMATE-RELATED FEDERAL LEGISLATION

John O'Donnell and Kyriakos Pagon from MMO Partners, a government relations firm, provided an update on climate-related federal legislation. Vice President Kyriakos Pagonis answered the Committee's questions.

5.2 **DECARBONIZATION GOAL ANALYSIS**

Chief Sustainability and Resiliency Officer Danielle Lee, Sustainability Manager Rebecca Lucky, Cascadia Consulting Group Associate Hailey Weinberg, and Cascadia Consulting Group Associate Alicia Fennell presented an update on the Decarbonization Goal Analysis. Chief Sustainability and Resiliency Officer Danielle Lee and Cascadia Consulting Group Associate Hailey Weinberg responded to the Committee's questions.

The Committee discussed the item.

Motion—M/S Clark/Showalter—Carried 3-0—To

- 1. Approve the five remaining local emissions-reduction actions outlined in the staff report for inclusion in the model. Additionally, incorporate sequestration from the Mountain View marshland. This brings the total number of local actions to eleven for modeling.
- 2. Direct the Project Team to develop a five-year decarbonization roadmap focused on achieving the 2045 decarbonization goal already adopted by the City Council. The CSC also expressed the inclusion or further evaluation of the following actions or approaches in the decarbonization roadmap:
 - Focus on substantial actions to reduce emissions, rather than prioritizing the achievement of a specific goal year.
 - Review the plan every 3 to 5 years.
 - Identify the most effective local actions to pursue in collaboration with Silicon Valley Clean Energy.
 - Determine which actions will result in utility or fuel savings.
 - Assess the impact of the time-of-sale action on housing costs and the City's capacity to implement and enforce regulations. Consider establishing a regional partnership to facilitate this action.
 - Engage local community groups to assist in educating the community.
 - Provide education on utilizing Mountain View's biking infrastructure.

- Collaborate to enhance shuttle services or explore the use of autonomous vehicles, such as those from Waymo and Uber, including minibuses.
- Conduct outreach and education for contractors regarding building electrification.
- Streamline permits for building improvements aimed at reducing emissions.
- Integrate emission reduction actions into other City policies and programs, including earthquake retrofitting and preparedness.

5.3 RESULTS OF THE EXTREME HEAT COMMUNITY PREPAREDNESS PROGRAM

Climate Fellow Grace Kann presented the results of the Extreme Heat Community Preparedness Program. Climate Fellow Grace Kann and Chief Sustainability and Resiliency Officer Danielle Lee responded to the Committee's questions.
