- 4.1 Amendments to Chapter 8 (Buildings), Chapter 25 (Neighborhood Preservation), Chapter 28 (Subdivisions),
 Chapter 32 (Trees, Shrubs and Plants), Chapter 35 (Water, Sewage and Other Municipal Services), and Chapter
 36 (Zoning) of the City Code (Second Reading)

This item was pulled from the Consent Calendar by Councilmember Ramirez for individual consideration.

Councilmember Ramirez directed questions to staff and asked for a response to concerns raised in a letter received from Building Industry Association.

Find the proposed amendments to Chapter 8 (Buildings), Chapter 25 (Neighborhood Preservation), Chapter 28 (Subdivisions), Chapter 32 (Trees, Shrubs and Plants), Chapter 35 (Water, Sewage and Other Municipal Services), and Chapter 36 (Zoning) of the Mountain View City Code to be exempt under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061, Subsections (b)(1) through (b)(3), as the amendments are to align with State legislation, implement adopted Housing Element programs, relate to ministerial activities otherwise categorically exempt under the CEQA Guidelines, and are otherwise covered by the common-sense exemption that the amendments will not result in a significant effect on the environment.
- 2. Adopt Resolution No. 18864 of the City Council of the City of Mountain View Making Findings Required by California Public Utilities Code Section 21676 and Overruling the Santa Clara County Airport Land Use Commission's Determination of Inconsistency with the Comprehensive Land Use Plan for Moffett Federal Airfield Related to Zoning Ordinance Text Amendments to Chapter 36 (Zoning) of the City Code to Align with Recently Enacted State Law, Implement 2023-2031 Housing Element Programs, Modify and Clarify Administrative and Development Review Procedures, and Make Other Nonsubstantive Amendments. (2/3 vote of the Council required)
- 3. Adopt Ordinance1.2024 of the City of Mountain View Amending Chapter 36 (Zoning) of the City Code to Align with Recently Enacted State Law and to Implement 2023-2031 Housing Element Programs, Including

Updates to Accessory Dwelling Unit and Junior Accessory Dwelling Unit Regulations, the Land Use Tables and Development Standards in Residential, Commercial, and Industrial Zones Related to Low-Barrier Navigation Centers, Child Day-Care, Employee Housing, and Other Residential Uses, and Parking Requirements, and Provisions for Micro-Enterprise Home Kitchen Operations and Hydrogen Fueling Stations; to Modify Provisions Related to Entitlement Applications, Development Review, Hearing and Extension Processes; to Clarify or Streamline Existing Procedures and Practices; to Incorporate Permit Provisions for Moving Buildings; and to Make Modifications, Clarifications, and Technical Corrections.

4. Adopt Ordinance 02.2024 of the City of Mountain View Approving Amendments to Chapter 8 (Buildings), Chapter 25 (Neighborhood Preservation), Chapter 32 (Trees, Shrubs and Plants), and Chapter 35 (Water, Sewage and Other Municipal Services) to Replace References to the Development Review Committee with Design Review, Align with State Laws on Electric Vehicle Charging Requirements and Micro-Enterprise Home Kitchen Operations, and Relocate Certain Accessory Dwelling Unit Provisions from Chapter 36 into Chapter 8; and Amendments to Chapter 28 (Subdivisions) to Modify Lot Line Adjustment Procedures and Clarify Existing Subdivision Map Extension Procedures.

4.2 Modifications to Council Policy A-11, Financial and Budgetary Policy

Adopt Resolution No. 18863 of the City Council of the City of Mountain View Amending City Council Policy A-11, Financial and Budgetary Policy.

4.3 South Bay Salt Pond Restoration, Project 18-53-Agreement with California State Coastal Conservancy

- 1. Authorize the City Manager or designee to execute a Memorandum of Agreement with the California State Coastal Conservancy to design and construct the erosion protection, Bay Trail reconstruction, and Mitigation Channel outfall projects at the Shoreline at Mountain View Regional Park to support the South Bay Salt Pond Restoration, Project 18-53, Phase 2 of the Alviso-Mountain View pond complex at Pond A2W.
- 2. Find that in accordance with the California Environmental Quality Act requirements, the erosion protection project is categorically exempt as Class 1, Existing Facilities, under California Public Resources Code Section 15301, and the Bay Trail reconstruction and Mitigation Channel outfall projects are categorically exempt as Class 1, Existing Facilities, and Class 2, Replacement or Reconstruction, under California Public Resources Code Section 15301 and Section 15302.

4.4 California Street (West) Complete Street Improvements, Pilot, Project 21-40-Professional Services Agreement

Authorize the City Manager or designee to amend the professional services agreement with BKF Engineers, a California corporation, for California Street (West) Complete Street Improvements, Pilot, Project 21-40, to add \$120,000 for a not-to-exceed amount of \$480,000.

4.5 San Antonio Area Sewer Improvements, Construction (Phase II), Project 19-45-Construction Contract

- 1. Appropriate and transfer \$494,000 from the Wastewater Capacity Fee Fund to San Antonio Area Sewer Improvements, Construction (Phase II), Project 19-45, increasing the project budget from \$2,349,000 to \$2,843,000. (Five votes required)
- 2. Authorize the City Manager or designee to award a construction contract to K.J. Woods Construction, Inc., for \$2,009,000, which includes a \$183,000 construction contingency.

Assistant Public Works Director/City Engineer Ed Arango, Principal Civil Engineer Robert Gonzales, Project Consultant Jim Lightbody; Robert Barnard, Deputy Chief, Rail Design and Construction, Caltrain; Marcella Rensi, Deputy Director, Grants & Allocations, Santa Clara Valley Transportation Authority were available for questions.

By consensus, the Council indicated support for the: 1) recommended reduction in the scope of the Castro

Project to the core bike/pedestrian undercrossing improvements; and 2) recommended implementation of project priority Alternative B – Prioritize Rengstorff Avenue Grade Separation, which includes an interim plan for the Castro Street crossing of the train tracks and Central Expressway.

The Council also indicated support for staff to:

- 1. Continue final design for the Castro Street Grade Separation Project.
- 2. Submit a letter signed by the Mayor to Caltrain requesting they help reduce project costs, including approving temporary suspension of train service and operations to support construction.
- 3. Increase the public art budget for the Castro Street Grade Separation Project.
- 4. Consider additional project scope for the Castro Interim Improvements, including no right-turn on red or a pedestrian scramble for the intersection of Moffett Boulevard and Central Expressway and neighborhood traffic control.
