WHEREAS, on November 15, 2024, the City Council interviewed applicants and made a recommendation for appointment on the Environmental Planning Commission;

WHEREAS, on November 22, 2024, the Council Appointments Review Committee interviewed applicants and made recommendations for appointments on the Board of Library Trustees, Human Relations Commission, Parks and Recreation Commission, Bicycle/Pedestrian Advisory Committee, Downtown Committee, Performing Arts Committee, Public Safety Advisory Board, Senior Advisory Committee, and Visual Arts Committee;

WHEREAS, on December 10, 2024, the City Council adopted Resolution No. 18955 to dissolve the Public Safety Advisory Board, which removed the need for appointments to the Public Safety Advisory Board; now, therefore, be it

Sandra Sommer is reappointed to the Parks and Recreation Commission for the January 1, 2025 to December 31, 2028 term; and

Terence Barton and James Kuszmaul are reappointed and Serge Bonte is appointed to the Bicycle/Pedestrian Advisory Committee for the January 1, 2025 to December 31, 2028 terms; and

Pamela Baird is reappointed to the Business-at-Large category for the January 1, 2025 to December 31, 2027 term, Jamil Shaikh is reappointed to the Neighborhood category for the January 1, 2025 to December 31, 2025 term, and Stephanie Lin is appointed to the Community-at-Large for the January 1, 2025 to December 31, 2027 term to the Downtown Committee; and

Nirvana Nwokidu is appointed to the Senior Advisory Committee for the unexpired term ending December 31, 2027; and
