## 4.1 Rental Housing Committee and Environmental Planning Commission Applicant Interviews

The purpose of this Study Session was for the Council to interview applicants for the Rental Housing Committee and the Environmental Planning Commission and make a recommendation for adoption at the November 7, 2023 City Council meeting.

There were no public speakers in-person or virtually.

The Council selected the following time allocation and questions to ask each Rental Housing Committee applicant:

1 minute: Tell us about yourself and what unique perspectives or abilities you would bring to the Rental Housing Committee.

2 minutes: Tell us about the role of the Rental Housing Committee and the role of its legal counsel in the Rental Housing Committee decision-making process. Have you read the Community Stabilization and Fair Rent Act?

2 minutes: What do you think will be the most important issues in the next year and how would you go about thinking them through and addressing them?
