As a follow up to our first email last week I wanted to send this one to you from an industry friend.

87% of the construction workforce statewide that chooses to be union-free. As a result PLAs reduce competition and increase costs. PLAs do this by, for instance, explicitly excluding state approved union-free apprentice programs. This is why the only state certified black apprentice program in California (the Black Contractors Association based in CA) opposes PLAs. Their apprentices, nor apprentices from ANY union-free apprentice program, are not allowed to be used under PLAs, period.
