During the COVID-19 pandemic, the City opened up Castro Street to pedestrians and restaurant seating, performing one of the most extreme transformations of Castro Street in recent memory under challenging circumstances. This change, while significant, has proved highly popular and serves as an important reminder that the key draw of our Downtown is its pedestrian-oriented character and the businesses that make up the Downtown, and that the purpose of those businesses is to serve people and not cars.

With that in mind, it is critical that, in anticipating for future growth, we plan with the objective of ensuring that Downtown is more accessible to more people while guiding that growth in a sustainable manner. And, by increasing the parking supply, Downtown will not achieve that objective. If we plan for the future of Downtown to include even current (let alone increases in) levels of traffic/parking, we are planning for a future in which we emit more greenhouse gases, generate more local pollutants, see more deaths from cars, waste land/money on vehicular infrastructure, reduce accessibility for those who cannot drive, and generally decrease the quality-of-life in our downtown core. To truly accommodate growth in the Downtown area, we must look instead to transportation solutions that can efficiently scale to accommodate more people—namely, walking, biking, and public transit.

To improve pedestrian and bicycle access, we can remove on-street parking to widen sidewalks and provide protected bike lanes; implement safety improvements at intersections; lower speed limits and implement traffic calming; plant trees to improve shade in the summer months; work with the VTA to provide bike-share programs; and encourage high-density residential developments with minimal car parking so that people can more easily live within easy walking distance of downtown.

For public transit, Caltrain's 2040 business plan includes plans to significantly increase off-peak service, as would be necessary to provide better access to Downtown in the evenings and on the weekends—during COVID, Caltrain has already increased its off-peak service to be better than it was before COVID to better reflect pandemic travel patterns. The Mountain View Community Shuttle Study includes potential provisions around improving hours of service. We should embrace these developments, and, rather than spending tens or hundreds of millions of dollars to build unnecessary and inefficient parking spaces, instead spend that money to support increased transit service downtown.

We ask that the City, instead of considering increases in parking supply, put a focus on shifting travel to non-car modes, while planning for a managed reduction in parking supply paired with a complementary investment in bike/pedestrian infrastructure and public transit operations, which, in addition to being the far more sustainable option, will also do far more to accommodate an increase in business in the downtown area.

If we are truly a City committed to sustainability, to Vision Zero, to accessibility, and to the ongoing growth and flourishing of our local businesses, we must be willing to embrace it fully, and not find ourselves burdened with caroriented planning that has poisoned America's urban life for the past 90 years.

In fact, I previously showed the Council that of all of the actions proposed under SAP-4, promoting plant-based diets is, by far, THE most cost effective way to reduce our residents' carbon-emissions, dollar for dollar. My analysis was done using data directly provided by the City's Sustainability team. Please see the table below (which I also presented in 2019).

Following this, Mountain View included a budget of \$30,000 for Plant-based diet promotion as part of SAP-4. This is a drop-in-the-bucket of the total SAP-4 budget, but we were happy to see at least some focus given to the urgent issue of diet change.

However, for the past year and a half, not single activity has been planned, not a single action has been taken to follow through on this commitment to promote sustainable diets. I understand that COVID has thrown a wrench into many plans, we lost a whole year where we could have been teaching our residents more about sustainable eating. There are numerous non-profits and speakers who offer free webinars and cooking courses on the subject; with most of us spending all of 2020 on ZOOM, it was the perfect opportunity to offer webinars to the community, and it would have cost very little. Why does this action continue to be pushed farther and farther out?

We continue to see the City place great emphasis and money on reducing transportation emissions, which is important. However, globally, the emissions due to animal food production exceeds those of the transportation

sector. The UN has asserted that there is NO way we can keep global temperature rise below 2 degrees C without a radical shift in dietary choices, particularly in Western countries. Why does this remain such a blind spot for us? Is it because we are afraid to restrict personal choice, and tell people what they should or shouldn't be eating? Well, we seem to be fine to recommend to people what they should and shouldn't drive, right? If we are afraid to talk about the impact of personal lifestyle choices, then we might as well give up entirely; because at present our personal choices are completely unsustainable. At the end of the day, you cannot force anyone to change the way they eat. However, what we *can* do is educate people about the consequences of diet choices, and allow people to make their own decisions. If people understand the gravity of the issue (which they currently do not), many of them would make positive changes.

I urge you to follow through with your commitment to promote sustainable plant-based diets in our City, as quickly as possible. I am connected to many groups that will provide free classes and webinars on this topic, and I am happy to help in any way I can. Thanks for hearing my comment.
