LAND USE AND COMMUNITY INVESTMENT IN MOUNTAIN VIEW Mountain View City Council Meeting – March 8, 2022

On Tuesday evening you will hear a presentation by Carducci Associates, the architect hired by the Mountain View Whisman School District to gather input from stakeholders about the use of the Monta Loma Elementary School site.

As you already know, the open green space is currently shared by many users, is heavily used, and is one of the last remaining large open green spaces in north Mountain View.

In our opinion, the entire Mountain View community should be working together to ensure that the Monta Loma green space remains open and accessible to everyone.

However, the solution is not to carve up the existing open field into defined use areas. Everyone values the openness of the green space and to design over the area would destroy that which is most precious to everyone including the school district, the city, the residents and our children.

We ask the City Council to view the issues surrounding Monta Loma Elementary within the broader context of land use in Mountain View and the importance of community investment.

As we all know, as Mountain View urbanizes, more pressure is placed on our remaining open space. At Monta Loma, our children, the school, the neighborhood, the residents living in north Mountain View, pet owners, seniors, and the sports teams, all recognize how important open green space is to them personally. We need to be honest with ourselves and acknowledge that there is not enough community and neighborhood park space to accommodate everyone's needs.

We therefore ask the City Council to begin the process of addressing the needs for community investment in our city. By community investment we broadly mean those aspects of a city that serve the underlying fabric that builds community including our schools, parks and open space, recreation, walkable and bikeable streets, tree canopy, sustainability, accessibility to shopping and restaurants, gathering spaces, libraries, entertainment, police and fire stations, and infrastructure such as parking, safe streets, underpasses, and public transportation, to name a few.

We ask the City Council to undertake the following:

- 1. Hold one or more Study Sessions on Land Use and Community Investment in Mountain View.
- 2. Direct City staff to initiate the Park and Open Space Strategic Plan Update. The community and the City Council set this as a high-priority item on the City's two year work plan, however, we are not aware of any progress on this to date.
- 3. Direct the City staff to assess community investment on a neighborhood scale, establish standards for community investments on a neighborhood level, and identify what the community investments needs are for each neighborhood throughout the city.



- 4. Direct City Staff to undertake an assessment of the extent to which developer fee structures and City policies ensure that adequate community investment is being made for new residential development. If these contributions are inadequate, determine how the community investment is to be funded.
- 5. In neighborhoods and areas of the city where there are legacy deficiencies, start developing meaningful plans to bring the community investment in these areas to an acceptable standard.

As we embark on a dramatic increase in residential housing in Mountain View and the continued construction of new commercial buildings, we believe that there is an urgent need to plan for community investment. As the situation with Monta Loma Elementary School demonstrates, where the city is down to one of the last open fields in north Mountain View, if we do not as a community begin honestly and seriously addressing the need for community investment in our City, it will become more and more difficult to provide the necessary community investment to make Mountain View a livable community.

We look forward to working with you and the City staff to ensure that Mountain View remains a great place to live, work, learn, and play.
