As we have an El Camino Healthcare District Board meeting tonight I am unable to attend your meeting and submit our comments on the 2023-2031 Housing Element.

We support the recommendation of staff to not include the South Drive area around El Camino Hospital in the Housing Element. There appears to be no interest in building housing in this area during the next eight years

The notion of including portions of the El Camino Medical Park Precise Plan Zoning in the Housing Element plan would reverse years of effort, planning, and investments, and would not uphold the integrity of the Plan,

or the medical needs of the community. We agree that housing is a significant issue and have confidence that the Council will maintain the integrity of the Precise Plan and keep the necessary health services in place.

In regard to the proposed El Camino Healthcare District's land on El Camino Real at Phyllis Avenue, healthcare services are the driving purpose for this land and as will be the same for all District owned land.

We reserve the right to make our own development decisions on this land in keeping with the mission of the Healthcare District for Mountain View and the surrounding community.

I have a question/comment regarding Agenda Item 3.1 (Housing Element). My family and I have lived in the Blossom Valley neighborhood for 12 years. I understand the City Council is considering redevelopment of the Blossom Valley Shopping Center at Miramonte and Cuesta. I want to emphasize that this shopping center is the most important element that makes Blossom Valley a walkable community. If it is redeveloped, particularly if the shopping center on Grant Road is redeveloped simultaneously, residents will need to drive to reach all of the everyday services we can now walk to at Blossom Valley Shopping Center. How would stores such as Safeway, CVS, Mail All, Dental Office, etc remain available to Blossom Valley residents during redevelopment? Also, would each of the current businesses have a place in the redeveloped mixed use center?
