The Alta developments at 1020 Terra Bella and 1012 Linda Vista are expected to be family-oriented. Many of the residents will be too young or otherwise unable to have access to an automobile. The office buildings in that area are either vacant or not used for purposes likely to be useful for Alta clients, i.e., shopping, employment, or school. This will result in a lot of foot and bicycle travel, which will require traffic safety upgrades: more effective controls on Terra Bella at Linda Vista and Shoreline, bike lanes, wider sidewalks, and parking prohibitions near street corners and driveways. Public transportation in this area is sketchy at best. MVgo ridership in the fourth quarter of 2022 was only about 25% of its pre-pandemic level, and is useless to anyone not named Google. If part of MVgo were repurposed to provide service to Alta/Terra Bella, Eden/Avenida and Crittenden Safe Parking, less of this resource would go to waste.
