We are an HOA of 302 condominium units located in the Willow Gate neighborhood between Central Avenue and Cypress Point Drive. We were very excited when Aki Snelling reached out to us to get our feedback on a proposed Precise Plan for the Moffett Blvd. Corridor. We had an initial meeting with her and there was a lot of positive interest in doing a Precise Plan for this area.

We believe that the City should take a holistic view and have a Precise Plan from Castro Street all the way to Moffett Field. With Berkeley Space Center at NASA Ames becoming a new innovation hub for aviation and space technology we need to be thinking about what the future of this neighborhood will become.

Thank you for the opportunity to comment on Item 3.1 Moffet Boulevard Precise Plan or Rezoning Scope of Work

On the questions posed by staff to the council:

- 1. We support doing a Moffett Precise Plan rather than simply rezoning the Moffett area to be in compliance with the 2023-2031 Sixth Cycle Housing Element. The Moffett area has been envisioned as an important change area ever since it was called out as such in the latest General Plan Update in 2012. This is the time to move forward with that vision and make Moffett a walkable, livable, and sustainable extension of our downtown. A rezoning-only approach is inadequate, as it would simply provide incentives to developers without taking into careful consideration the needs of current and future residents of the Moffett area. 



Hello Willowgate Community. My name is Daniel Shane and I am a homeowner in Mountain View. I live on I represent the Cypress Point Community Preservation Group. Our initial effort was to submit comments on the draft and final EIR for the 555 W Middlefield Road High Density Housing Development on our street. The key issues was the preservation of several majestic redwood trees the developer proposed to cut down and better integration of the surrounding natural environment and its ecosystems with the development. Of primary concern was the protection and restoration of hundreds of evergreen trees that form a highway vegetation barrier (HVB) between Highway 85 and thousands of people living in multi-family residential housing near the freeway. The developer proposed to cut down all the trees. HVBs that are tall and continuous with overlapping canopies and dense foliage provide protection from high levels of noise and air pollution, both particulate matter, vapors and gases, emitted by cars and trucks on the freeway. These toxic and carcinogenic airborne contaminants and pollutants are particularly harmful to children. The project plan design was approved by City Council as specified. We continue to press the City Council and the developer to integrate the HVB and deed the land it is on to the city for care, maintenance, and enhancement. If you are interested, I can send you a draft paper on this public health and environmental issue at
