A pooled fund specifically directed at displacement prevention would be a welcome strategy, especially when linked to a community ownership model.



We will continue to support the Fondo de Solidaridad | Mountain View CLT as they work towards establishing a community land trust and acquiring their first building as a demonstration project in the coming months. Honorable Mayor and council members, we hope this message finds you well.

The Mountain View Tenants Coalition (MVTC) is a grassroots organization that, since its inception in 2014, has been dedicated to combating community displacement and advocating for rent control measures. These efforts have had a significant, soothing impact, ensuring the continued residence of a vital segment of the city's working population in Mountain View.

We are grateful for the efforts of the staff in compiling this report and for the city council's decision to prioritize this issue. Following our translation of the report, we wish to express our concern regarding the current proposal's lack of clarity on the immediate benefits of allocating funds to any group at this time. Instead, we suggest that a detailed explanation of the criteria for accessing similar funds would be greatly beneficial, especially for community organizations like ours that are likely to be interested in applying for them.

Our coalition has been a vocal proponent of community housing solutions, viewing them as crucial countermeasures against the displacement and gentrification of vulnerable communities. We are thus heartened by the comprehensive strategy that includes the Owner's Purchase Agreement (OPA), recognizing these initiatives as positive steps forward. While we understand the decision to incorporate a consultant into this framework, we stress the importance of ensuring that this individual works closely with the community. Their role should primarily focus on facilitating the successful implementation of the OPA.

Furthermore, we support the ongoing efforts to reinforce the Mobilehome Residents' Stability Ordinance (MHRSO), Tenant Relocation Ordinance (TRO), and the creation of new ordinances to safeguard tenant rights following the expiration of SB330. This approach mirrors our stance on finding legislative alternatives to SB649 that favor local tenants.

We sincerely hope that our feedback is taken into consideration as we continue to strive for the betterment of our community. We look forward to further collaboration and remain committed to the cause.
