SUBJECT: Additional Update of Attachment-1 to Council Goal Setting for Fiscal

Years 2019-20 and 2020-21 – Phase II Study Session Memo

Staff received a number of City Council questions regarding whether certain projects that Council has directed staff to undertake need to be voted on. In response to these questions, staff has reviewed the project ranking sheet and updated the document to reflect additional projects that do not need to be voted on. These projects will be added to the Fiscal Years 2019-20 and 2020-21 City Council Goals Work Plan.

Given these changes, the number of votes per section is now as follows:

#### Non-Goal Related Proposed Projects from the EPC

Staff only solicited advisory body input on projects related to Council's four major goals. The EPC proposed two non-goal related projects, which staff did not include on the project ranking sheet. If the City Council desires, they may add these projects for ranking during the Study Session.

#### The projects are:

- I. Install fiber throughout the City.
- II. Create a Multi-Family Design Study and Handbook (interest expressed by the City Council and EPC. Staff prepared and presented general information study in 2018).
  - o Include townhouse and rowhouse developments and larger multi-floor buildings.
  - o Include examples of good local architecture (different styles and quality materials).
  - Possibly include a special Downtown review and evaluation section (different standards/styles)
  - o Study could include transition guidelines (multi story to lower story neighborhoods)
  - o Study could be used to update various City design Guidelines or standards, zoning updates, Precise Plans.
