- 23 planned **discretionary** (Attachment 4) including three modifications and seven new projects
- Six projects planned for deferral
 - 3 project amendments

- CDD Permit Center Space Study (\$160,000)

Transportation Funding

- June 26, 2018: Council adopted a resolution specifying an intention to use 80% of the increased revenue from the business license tax for transportation and innovation transit solutions
- Per Shuttle Study nearly \$3.3 million(2024 dollars) or ~2/3 of revenue needed to operate the community shuttle
 - Staff recommends that the remaining 1/3 of the revenue be reserved for transportation projects

Council Questions

<u>Question 1:</u> Does the City Council support staff's recommendation to not add limited-period resources at this time in an effort to focus resources on completing bicycle and pedestrian projects currently underway.

<u>Question 2:</u> Does the City Council support the Fiscal Year 2020-21 CIP project recommendations, including the roll-forward, modified non-discretionary and discretionary projects, amendments to existing projects, and new projects as shown in Attachments 3 and 4?

<u>Question 3:</u> Does the City Council support the recommendation that onethird of the annual business license tax revenue reserved for transportation purposes be allocated to transportation projects?

Based on Council's direction, staff will prepare the Proposed Fiscal Year 2020-21 CIP for Council consideration on June 9, 2020.
