Re: 5.2 Update to Community Tree Master Plan

## **Dear PRC Commissioners:**

The Mountain View Coalition for Sustainable Planning (MVCSP), in collaboration with GreenSpacesMV, appreciates the opportunity to respond to the Update to Community Tree Master Plan agenda item for your meeting on the 10th. We have reviewed the Staff memorandum, and we have the following comments we would like to share with you.

We are very interested in seeing the following addressed during the update process:

- Increased tree canopy: Such increases would provide both a carbon and heat sink, and increased shade, which contributes to energy efficiency for our homes and other structures. There can also be traffic calming benefits as well; applying Complete Streets and Green Streets concepts can be useful on this front.
- Tree choices, including best types by location: The updated plan should help ensure that native, drought-tolerant, and pollinator-friendly landscaping is emphasized, that migration paths are protected, and that cone-dropping or low-hanging trees adjacent to sidewalks and bikeways are not allowed (if applicable). Likewise, please ensure no trees attractive to aphids, such as tulip trees, which can result in sticky droppings on sidewalks, are included in the plans. - Tree placement considerations: Some areas of the city are better populated with trees than others. Placement in unusual, unused, or underused areas generally should be promoted as well.

- Support Community/City collaboration opportunities: Groups such as ours can provide the community end of potential program design; also GreenSpacesMV, Mountain View Trees, Soil&Water, Friends of the Stevens Creek Trail, Canopy, and neighbor groups through the City Cool Block program.
- Integrated approaches consideration: Any work that disrupts a part of our city should be leveraged if
  possible for additional work at the same time where increases in tree canopy might be achieved. One
  detail in this area is that any canopy plan should look at the impact of above-ground power lines and how
  their location and maintenance can impact health of trees and limit the planting of trees. Guidelines for
  city plans for undergrounding utility lines should be presented as a way to promote a diverse and healthy
  canopy.
  - One question: Is it possible to overlay upcoming projects on an interactive map where there are impacts on public streets, bikeways, or sidewalks?
- Regarding tree removal: The update should include coverage on tree removal policy, whether for heritage
  or non-heritage trees, such as why any must be removed and what the replacement strategy will look like.
  We would like to point out that any new trees take a number of years to reach maturity and fully
  contribute to the overall city canopy. Also, please consider requiring developers to include in the arborist
  reports the dollar amount of assessed value of all trees that are proposed to be removed, including
  heritage trees, so the community has a better sense of the impact of tree removals in proposed
  development projects.
- **Stormwater management**: This can have an impact on nearby trees. Unless the details are covered elsewhere, it would be good to include in this update.

**Process of updating the Plan:** We would like to see robust community outreach and input gathering, as well as inter-department collaborations with Community Development, Public Works, the Sustainability team and others, including community stakeholders.
